

RESOLUTION NO. 26-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING A CONSTRUCTION AGREEMENT WITH THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION FOR THE CONSTRUCTION OF STREET LIGHT IMPROVEMENTS WITHIN THE RIGHT-OF-WAY OF STATE ROAD 811 FOR THE STREETScape IMPROVEMENTS PROJECT LOCATED ON NORTHEAST 4TH AVENUE, IN THE CITY OF FORT LAUDERDALE, FLORIDA, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Northeast 4th Avenue Streetscape Improvement Project (“Project”) is located on Northeast 4th Avenue, between Sunrise Boulevard and Northeast 13th Street, in the City of Fort Lauderdale, Florida (“City”); and

WHEREAS, the Project scope includes widening existing sidewalks, installation of new trees and irrigation systems, signage, and the infrastructure for future street lighting; and

WHEREAS, the proposed decorative streetlight fixtures improvements to the Project is within the limits of the Florida Department of Transportation’s (“FDOT”) right-of-way of State Road 811 between Mile Post 0.000 to Mile Post 0.696; and

WHEREAS, FDOT requires the City to enter into a Construction Agreement in order to construct the streetlight fixtures improvements within FDOT’s right-of-way as part of the general permitting process; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA THAT:

SECTION 1. The recitals set forth above are true and correct and are incorporated in this Resolution.

SECTION 2. The City Commission of the City of Fort Lauderdale hereby approves the construction agreement with the State of Florida Department of Transportation for the construction of street light improvements within the right-of-way of State Road 811 for the Streetscape Improvements Project located on Northeast 4th Avenue, in the City of Fort Lauderdale, Florida.

SECTION 3. The Office of the City Attorney shall review and approve as to form all documents prior to their execution by City officials.

SECTION 4. This Resolution shall be in full force and effect upon adoption.
