TITLE: Motion to Approve Contract for Purchase of Comprehensive Planning

Consultant Services – The Corradino Group, Inc. - \$247,000

Recommendation

It is recommended that the City Commission approve a contract, in substantially the form attached, with The Corradino Group, Inc. for the purchase of comprehensive planning consultant services for Phase II of the City's Comprehensive Plan (Plan) Update in the amount of \$247,000.

Background

The Department of Sustainable Development is taking the lead in amending the Plan in a two-step process. In Phase I, the Department, with assistance of comprehensive planning consultant, The Corradino Group, Inc., prepared the Evaluation and Appraisal Report (EAR) which was adopted by the City Commission in February 2016. Phase II will include the preparation of Volume I of the Plan (Goals, Objectives and Policies) based upon the EAR and the updated Data Inventory and Analysis. The updated Plan will be prepared in a concise, user-friendly format that matches the graphic template of the Fast Forward and Press Play documents, including illustrative examples. The consultant will also provide a detailed public outreach plan, considering larger forums as well as smaller sub-groups of stakeholders in preparation of the Plan's goals, objectives, and policies. Public participation for the Plan update is expected to begin in fall, 2017.

The background of the solicitation process for Phase II includes the following:

- January 20, 2017 Request for Proposal (RFP) 575-11886 was issued for comprehensive planning consultant services.
- February 23, 2017 The RFP closed with a total of three firms submitting proposals including:
 - Calvin Giordano & Associates, Inc.
 - > The Corradino Group, Inc.

- Stantec Consulting Services Inc. (did not agree to accept the p-card for payment as required in the specifications and is therefore deemed non-responsive)
- April 6, 2017 The evaluation committee consisting of Lorraine Tappen, Principal Planner; Glen Hadwen, Sustainability Manager; Christine Fanchi, Planner II; Gina Rivera, Grants & Special Projects Coordinator; and Jim Hetzel, Principal Planner met with AnnDebra Diaz, Senior Procurement Specialist, to evaluate and rank the two remaining responsive firms based on the evaluation criteria shown below:

The firms were ranked as follows:

The Corradino Group, Inc. (1st Place) Calvin Giordano & Associates, Inc. (2nd Place)
