## RESOLUTION NO. 22-157

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, TO REINSTATE AND EXPAND THE GALT MILE LINK SERVICE HOURS AND EXPAND THE SERVICE HOURS FOR THE BEACH LINK, DOWNTOWN LINK, LAS OLAS LINK AND NEIGHBORHOOD LINK; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City has been a partner in Broward County's Community Shuttle Program since September 15, 2009; and

WHEREAS, LauderGO! Community Shuttle is a free transportation option for City of Fort Lauderdale residents and visitors that improves mobility and connectivity within the City, covers areas that larger Broward County Transit (BCT) buses are unable to serve, and links passengers to destinations across the city and to the larger transit network; and

WHEREAS, the changes to the operating service are as follows:
