TITLE: Motion to approve Work Order No. 1 in the amount of \$24,740, Work Order No. 2 in the amount of \$22,230, Work Order No. 3 in the amount of \$20,624, Work Order 4 in the amount of \$20,374, and Work Order No. 6 in the amount of \$120,430 under the Annual Sewer Repair Contract with Lanzo Lining Services, Inc.-Florida, Project 11577

Recommendation

It is recommended that the City Commission approve Work Order No. 1 in the amount of \$24,740, Work Order No. 2 in the amount of \$22,230, Work Order No. 3 in the amount of \$20,624, Work Order No. 4 in the amount of \$20,374, and Work Order No. 6 in the amount of \$ 120,430 under the Annual Sewer Repair Contract with Lanzo Lining Services, Inc.-Florida, Project 11577.

Background

In compliance with Section 2-179(5) of the City Code of Ordinances, all work orders under any annual contract in a cumulative over \$25,000 must be brought back to the City Commission for approval.

The Annual Sewer Repair contract provides the City with the ability to complete gravity sewer and storm drain repairs that are beyond the capability or capacity of City crews and equipment. The contract was awarded to Lanzo Lining Services, Inc.-Florida, in the not to exceed amount of \$1,689,732.60 Work orders are assigned only on an as-needed basis, per available funds, and the contract sum is not a guarantee of the amount of work that will be issued.

Work Order No. 05 was the first work order executed under the Annual Sewer Repair contract. The scope of work included emergency sewer repairs at 3250 Northeast 38th Street and 1736 Southwest 4th Court, in the amount of \$24,990. This work was completed on September 6, 2013.

The scope of work listed below is being submitted for City Commission approval to be executed under the Annual Sewer Repairs Contract for a total amount of \$208,398 and consists of five work orders:

Work Order No. 1: encompasses four (4) locations: 1) lining of 700 linear feet along an existing 12-inch sewer gravity main at three different sections (2200 Northwest 62nd Street) and 2) lining of 130 linear feet of 12-inch storm drain (1651 Southeast 8th Street).

Work Order No. 2: encompasses four (4) locations: 1) lining of 150 linear feet of 10-inch corrugated metal pipe (1332 Mango Isle), 2) lining of 35 linear feet of 10-inch corrugated metal pipe (2506 Lucille Drive.), 3) lining of 186 linear feet of reinforced concrete pipe storm drain (2612 Northeast 32nd Avenue), and 4) lining of 170 linear feet of 12-inch corrugated metal pipe (2506 Lucille Drive).

Work Order No. 3: encompasses four (4) locations: 1) lining of 123 linear feet of 12-inch diameter concrete pipe (6340 Northeast 15th Avenue), 2) lining of 145 linear feet of 18-inch diameter reinforced concrete pipe storm drain, 3) lining of 49 linear feet of 10-inch reinforced concrete pipe storm drain (5620 Northeast 31st Avenue), and 4) lining of 128 linear feet of 18-inch diameter corrugated metal pipe (3360 Northeast 42nd Court).

Work Order No. 4: encompasses three (3) locations: 1) lining of 150 linear feet of 15-inch diameter reinforced concrete pipe storm drain (1736 Southwest 4th Court), 2) lining of 255 linear feet of 10-inch vitrified clay pipe (between Northwest 29th Avenue and Northwest 28th Way on 68th Street), and 3) lining of 269 of 10-inch vitrified clay pipe (between Northwest 28th Way and Northwest 28th Terrace on Northwest 68th Street).

Work Order No. 6: encompasses sixteen locations: 1) lining of 2400 linear feet of 8-inch gravity sewer main (3160 Northwest 69th Court, 1473 Northeast 57th Place, 1721 Northeast 54th Street, Northeast 33rd Avenue and Oakland Park, 3167 Northwest 68th Street, Northeast 14th Court and North AIA Boulevard., 1813 North Ft. Lauderdale Beach Boulevard., Northeast 16th Street and AIA), 2) lining of 2005 linear feet of 10-inch sewer gravity (Northwest 7th Avenue and Northwest 19th Street, Northwest 28th Avenue and Northwest 19th Street, Northwest 58th Street and Northwest 26th Way, Northwest 28th Avenue and Northwest 19th Street, Northeast 16th Street and Northeast 17th Street on Bay View Drive, Northwest 25th Way and Northwest 68th Street), 3) lining of 128 linear of 12-inch storm liner (2878, Northeast 24th Court), and 4) special cleaning (East Oakland Park Boulevard and Northeast 32nd Avenue).

Resource Impact

There is a fiscal impact to the City in the amount of \$208,398 for the work orders and \$31,259.70 for engineering fees, totaling \$239,657.70.
