

RESOLUTION NO. 25-147

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, BROWARD COUNTY, FLORIDA, ADOPTING AND APPROVING THE TENTATIVE BUDGET OF THE CITY OF FORT LAUDERDALE, FLORIDA, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2025, AND ENDING SEPTEMBER 30, 2026, WHICH INCLUDES THE BUDGET FOR THE GENERAL FUND, WATER AND SEWER/CENTRAL REGIONAL WASTEWATER SYSTEM FUNDS, SELF-INSURED HEALTH BENEFITS FUND, STORMWATER FUND, SANITATION FUND, DEBT SERVICE FUNDS, CENTRAL SERVICES (ITS)/UNIFIED CUSTOMER SERVICE FUNDS, PARKING FUND, BUILDING FUNDS, FLEET FUND, CITY PROPERTY & CASUALTY INSURANCE FUNDS, GRANT, BOND, AND RESERVE FUNDS, AIRPORT FUND, COMMUNITY REDEVELOPMENT AGENCY FUNDS, CEMETERY SYSTEM FUND, PROJECT MANAGEMENT FUND, TRANSPORTATION SURTAX FUND, CEMETERY PERPETUAL CARE FUND, ARTS AND SCIENCE DISTRICT GARAGE FUND, MARINE FACILITIES FUND, SCHOOL CROSSING GUARDS FUND, BEACH BUSINESS IMPROVEMENT DISTRICT FUND, NUISANCE ABATEMENT FUND, SUNRISE KEY NEIGHBORHOOD IMPROVEMENT DISTRICT FUND, AND POLICE CONFISCATION FUNDS, TENTATIVELY ADOPTING AND APPROVING THE CITY OF FORT LAUDERDALE PERSONNEL COMPLEMENT FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2025, AND ENDING SEPTEMBER 30, 2026, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, in accordance with the applicable provisions of the law, the City Commission of the City of Fort Lauderdale, Florida, has prepared a tentative budget for the City of Fort Lauderdale, which includes the General Fund, Water and Sewer/Central Regional Wastewater System Funds, Self-Insured Health Benefits Fund, Stormwater Fund, Sanitation Fund, Debt Service Funds, Central Services (ITS)/Unified Customer Service Funds, Parking Fund, Building Funds, Fleet Fund, City Property & Casualty Insurance Funds, Grant, Bond, and Reserve Funds, Airport Fund, Community Redevelopment Agency Funds, Cemetery System Fund, Project Management Fund, Transportation Surtax Fund, Cemetery Perpetual Care Fund, Arts and Science District Garage Fund, Marine Facilities Fund, School Crossing Guards Fund, Beach Business Improvement District Fund, Nuisance Abatement Fund, Sunrise Key Neighborhood Improvement District Fund, and Police Confiscation Funds, for the fiscal period beginning October

1, 2025, and ending September 30, 2026, and determined the amount of available funds on hand, the estimated revenues, and appropriated amounts for the support of the various operations of the City for such fiscal period; and

WHEREAS, notices advising the public that a public hearing on the proposed tentative budget would be held on September 3, 2025, at 5:01 p.m., or as soon thereafter as possible, before the City Commission at the Broward Center for the Performing Arts – Mary N. Porter Riverview Ballroom, 201 SW 5<sup>th</sup> Avenue, Fort Lauderdale, Florida, have been published; and

WHEREAS, a public hearing has been held, and comments from the public, if any, concerning the tentative budget have been heard and considered; and

WHEREAS, as set forth during the tentative budget hearing the City Commission acknowledges that the tentative budget reflects the following revenue and expenditure estimates for the Fiscal Year beginning October 1, 2025, and ending September 30, 2026, for all funds, totaling \$1,194,366,687:

WHEREAS, a Personnel Complement for the fiscal year beginning October 1, 2025, and ending September 30, 2026, has been proposed; and

WHEREAS, it is the desire of the City Commission of the City of Fort Lauderdale, Florida, to adopt and approve a tentative budget and a tentative Personnel Complement for the fiscal year beginning October 1, 2025, and ending September 30, 2026;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the tentative budget, titled "FY 2026 Tentative All Funds Budget Summary," to wit, Exhibit 1 to City Commission Agenda Memo #25-0706, is hereby adopted and approved as the tentative budget of the City of Fort Lauderdale for the fiscal period

beginning October 1, 2025, and ending September 30, 2026, and is incorporated herein by this reference.


SECTION 2. That the City of Fort Lauderdale Personnel Complement, to wit, Exhibit 3 to City Commission Agenda Memo #25-0706, is hereby tentatively adopted and approved for the fiscal period beginning October 1, 2025, and ending September 30, 2026, and is incorporated herein by this reference.

SECTION 3. That the Tentative Operating Budget for Fiscal Year 2026 establishes limitations on expenditures and expenses by fund total, so that the total sum allocated to each fund for total expenditures and expenses may not be increased without specific authorization by a duly enacted resolution effecting such amendment or transfer.


SECTION 4. That a public hearing to adopt a final budget shall be held in accordance with Section 200.065, Florida Statutes.

SECTION 5. That this Resolution will take effect immediately upon its adoption.
