City Attorney Boileau explained details of his contract with the City, including twenty (20) weeks of severance pay with benefits and accrued paid vacation and sick time, similar to other Charter Officers under contract with the City. City Attorney Boileau expounded on details related to his immediate placement on administrative leave. Further comment and discussion ensued.

Commissioner Glassman remarked on his opposition as discussed at today's Commission Conference Meeting and explained his perspective. His concerns included the impact on Staff and residents, and the lack of a transition period. Commissioner Glassman expounded on his viewpoint.

Vice Mayor Sturman suggested not letting City Attorney Boileau go immediately and providing City Attorney Boileau thirty (30) to sixty (60) days' notice to allow him to assist with the transition to a new City Attorney.

Commissioner Herbst commented on his understanding relative to placing City Attorney Boileau on administrative leave and maintaining access to email, which would be at the discretion of City Manager Chavarria. Further comment and discussion ensued.

In response to Mayor Trantalis' question, Commissioner Beasley-Pittman confirmed this action would be immediate. City Attorney Boileau waived the requirement of the City to provide written notice included in his contract.

In response to Commissioner Glassman's request for clarification, Mayor Trantalis said City Attorney Boileau would be on administrative leave immediately, and any work Mr. Boileau does for the next sixty (60) days would be voluntary to assist Mr. Spence. Further comment and discussion ensued.

In response to Vice Mayor Sturman's comment regarding the option of giving City Attorney Boileau thirty (30) days' notice, Mayor Trantalis noted that Commissioner Beasley-Pittman did not include that option in her motion.

Mayor Trantalis sought clarification regarding the intent of the Commission. The Commission discussed the matter and confirmed the Commission's intent was reflected in the initial motion by Commissioner Beasley-Pittman to place City Attorney Boileau on administrative leave. Further comment and discussion ensued. City Attorney Boileau reaffirmed his right to be compensated during the 60-day period of administrative leave, and waived the formality of written notice included in his contract.

Commissioner Beasley-Pittman amended her motion to reflect placing City Attorney Boileau on administrative leave immediately and was seconded by Vice Mayor Sturman.
