TITLE: Motion to approve a one-year contract for international waste disposal –

Invitation to Bid (ITB) 533-11227 - \$45,980

Recommendation

It is recommended that the City Commission approve a one-year contract for the purchase of international waste disposal to Waste Services of Florida, Inc. in the estimated amount of \$45,980 and authorize the City Manager to approve the renewal options contingent upon approval and appropriation of funds.

Background

The Fort Lauderdale Executive Airport has an onsite U.S. Customs and Border Protection (CBP) facility. The airport supports flying throughout the world and has the second busiest CBP General Aviation Facility (GAF) in the United States. The airport is a major international gateway with operators serving destinations throughout the Caribbean, Central America, South America and beyond, fulfilling its role as a reliever airport for Fort Lauderdale-Hollywood International Airport (FLL). The CBP facility operates daily to process general aviation international flights from 8 a.m. to 9 p.m. and is required to handle and properly dispose of the food and trash generated from inbound flights. To ensure timely responses by legitimate vendors all bidders were required to be a pre-approved vendor on the United States Department of Agriculture (USDA)/CBP list of Cartage Firms authorized to handle International Regulated Waste.

Invitation to Bid 533-11227 was issued on May 3, 2013. With only one bid received at the scheduled bid-opening day, the bid was extended in an attempt to obtain additional competitive bids; however, no other bids were received. Waste Services of Florida, Inc. has met all requirements and has been deemed the single responsive and responsible bidder.

Resource Impact

There will be a fiscal impact to the City in the amount of \$45,980. Future expenditures are contingent upon approval and appropriation of the FY 2014 annual budget.
