TITLE: Motion Approving an Agreement for the Purchase and Installation of Two

Submersible Mixers - Odyssey Manufacturing Co. - \$147,000 -

(Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve an agreement, in substantially the form attached, with Odyssey Manufacturing Co. for the purchase and installation of two (2) submersible mixers for use in the water storage tanks at the Fiveash Water Treatment Plant in the amount of \$147,000.

Background

In November 2022, the City had an evaluation/inspection conducted by the Environmental Protection Agency, Florida Department of Environmental Protection (FDEP), and National Enforcement Investigation Center. Several issues were identified during the inspection, and resolutions to the various issues are still ongoing. In the response letter to the FDEP, one (1) of the actions to be taken by the City is to install a tank mixing system at each of the two (2) water storage tanks at the Fiveash Water Treatment Plant. The implementation of this mixer system will improve the quality of potable water delivered to customers.

On July 31, 2024, the Procurement Services Division issued Invitation to Bid Event No. 347 – Submersible Mixer for Water Storage Tanks. The event was extended three (3) additional times while outreach was done to increase competition. On August 27, 2024, the solicitation ended with one (1) bid. The bid provided by Odyssey Manufacturing Co., has met the requirements of the bid and is deemed responsive and responsible bidder. The bidder has not indicated their status as a Disadvantaged Business Enterprise.

Resource Impact

There will be a fiscal impact to the city in the amount of \$147,000. Funding is available in the amount of \$147,000 in the FY 2025 Operating Budget in the account listed below.
