Brief Description of Project:

This project seeks to obtain 1 set of boat engines in order to replace the engines on FLPD's Marine Unit Boat #12 which are out of warranty and have logged several thousand miles over the manufacturer's recommended usage. When the engines are out of service, the Marine Unit's ability to patrol Fort Lauderdale's 84 miles of navigable waterways is diminished.


