

## AMENDMENT TO LARGE USER WASTEWATER AGREEMENT

THIS Amendment to Large User Wastewater Agreement, made and entered into this 27 day of January, 2022, is by and between:

CITY OF FORT LAUDERDALE, a municipal corporation of the State of Florida (hereinafter referred to as "FORT LAUDERDALE")

and

CITY OF TAMARAC, a municipal corporation of the State of Florida (hereinafter referred to as "TAMARAC," collectively referred to as "Parties")

On April 20, 1982, FORT LAUDERDALE and CITY OF TAMARAC entered into a Large User Wastewater Agreement.

On August 1, 2001, FORT LAUDERDALE and CITY OF TAMARAC entered into an Amendment to Large User Wastewater Agreement, which extended the term of the Agreement until December 31, 2021.

FORT LAUDERDALE and TAMARAC desire to enter into this Amendment to extend the term of the Agreement an additional ninety (90) days until March 31, 2022, to allow the Parties to finalize a new Large User Wastewater Agreement and allow the time for both Parties' respective governing bodies to approve said Agreement.




All other terms and conditions of the Large User Wastewater Agreement remain unchanged and in full force and effect.
