Dear City Engineer:

In accordance with Section 25-100.B.1 of the above-referenced ordinance ("Ordinance"), BellSouth Telecommunications, Inc. d/b/a AT&T Florida submits this application for an exemption from the below grade requirement. As demonstrated below, an exemption is appropriate, as a hardship would result from the imposition of the requirement.

Placing the communications service facility described in the attached right-of-way permit application ("Facility") below grade is technologically infeasible, a below grade facility is not available in the marketplace and all reasonable alternatives have been exhausted. As required by Section B.3. of the Ordinance, information prepared by qualified experts certifying technological infeasibility and evidence that all reasonable alternatives have been exhausted follows:

- (1) Attached as Attachment 1 is information supporting this exemption application that was prepared and certified by the undersigned expert.
- (2) The November 15, 2007 report prepared by Power Services for the City, already on file with the City and titled: Independent Review of Communications Equipment Options Related to the AT&T Lightspeed Program (the "Power Services Report"), also includes information that supports this exemption application. The Power Services Report confirms that a below grade facility is not currently available in the marketplace, noting that Power Services "found only one vendor with a [Flush to Grade facility] close to potential application for the Lightspeed project. . . ." and adding that additional development, testing and certification would be necessary for its use. *Executive Summary of Power Services Report*, pages 4-5, 7. The Power Services Report also confirms that, for any flush to grade solution, ". . . there will be an above-grade footprint for access, ventilation, and cooling[.]" Accordingly,

the report concludes not only that an entirely below grade solution does not currently exist but will not exist in the future. *Executive Summary of Power Services Report*, page 6. While AT&T Florida does not agree with all of the information in the Power Services Report (including, without limitation, disagreement with the suggestion that the one "passive" flush to grade product identified in the report could be used for the "active" electronics purpose for which the Facility is necessary), AT&T Florida does agree with the conclusion that no below grade facility is currently available in the marketplace.

Submittal of this application for exemption by AT&T Florida should not be construed as AT&T Florida's agreement with the City's authority to impose the below grade requirement in the Ordinance under applicable law, and AT&T Florida reserves all rights in that regard.
