- Complete application submittal on lauderbuild to the Zoning & Landscaping Division of the Development Services Department. The application submittal must include City Commission Approval and Hold Harmless Agreement (must be signed and notarized).
- 2. Application review and approval through the Administrative Review Process
- 3. Commission Reguest for Review (CRR) period of fifteen (15) days
- 4. Final approval of banner request
- 5. Zoning Administrator signature required prior to submittal for permitting




