TITLE: Motion to approve an agreement for medical director services for the
Fire-Rescue Department - \$150,865.48

Recommendation

It is recommended that the City Commission approve an agreement, in substantially the form attached, for a three-year period for medical director services for the Fire-Rescue Department to Nabil El Sanadi, M.D. The City Commission is further requested to authorize the City Manager to approve two, one-year renewal options, contingent upon appropriation of funds.

Background

Fire-Rescue staff requests that the City Commission award a three-year contract to Nabil El Sanadi, M.D. for responsible medical and administrative oversight for the City's delivery of basic and advanced life support emergency medical services. These services are provided by Fire-Rescue paramedics and emergency medical technicians under the direction of a licensed physician.

Pursuant to Section 2-172(a)(8) of the Code of Ordinances of the City of Fort Lauderdale, Florida, the Procurement division of the Code of Ordinances does not apply to professional medical services.

Resource Impact

There is a financial impact to the City in the amount of \$49,296 with a 2% cost of living increase annually for a total of \$150,865.48 over the three-years for medical director services.

There will be a fiscal impact to the City in the amount of \$49,296 in FY 2014. Future expenditures are contingent upon approval and appropriation of the annual budget. Future year expenditures will be \$50,281.92 in FY 2015, \$51,287.56 in FY 2016.
