Section A

- 1. Summary of the proposed ordinance, to include the public purpose to be served by the proposed ordinance, such as serving the public health, safety, morals, and welfare of the City.**

The proposed ordinance revision includes amending Chapter 26 to establish a school zone speed enforcement program and authorize the use of speed detection systems within the City.

- 2. Estimate of direct economic impact of the proposed ordinance on private, for-profit businesses in the City.**

- a. Estimate of direct compliance costs that businesses may reasonably incur if the ordinance is enacted.**

A business that operates a vehicle that violates the posted speed limit within a school zone will incur a \$100 penalty.

- b. Identification of any new charge or fee on businesses subject to the proposed ordinance or for which businesses will be financially responsible.**

The proposed ordinance will have no new direct fee for which the businesses will be financially responsible for.

- c. An estimate of the City's regulatory costs, including an estimate of revenues from any new charges or fees that will be imposed on businesses to cover such costs.**

The proposed ordinance will have no impact on the City's regulatory costs and will generate revenue from the violation penalties. There is not enough available data to estimate the amount of revenue that could be generated from impacted businesses.

There is not enough available data to provide this estimate. This estimate will be contingent on the number of businesses that currently incur speeding violations.
