**TITLE**: Motion Approving an Agreement for the Dorsey Riverbend Stormwater

Improvements Project - Man-Con, Incorporated - \$33,841,618.20 -

(Commission District 3)

## **Recommendation**

Staff recommends the City Commission approve an agreement, in substantially the form attached, for the Dorsey Riverbend Stormwater Improvements Project, with Man-Con Incorporated, in the amount of \$33,841,618.20, which includes allowances of \$2,275,000.

### **Background**

The purpose of this project is to install new and repair existing stormwater infrastructure within the Dorsey Riverbend Neighborhood. The project will address flooding concerns in the neighborhood by improving the stormwater collection and conveyance infrastructure. The project also includes a new stormwater pump station, neighborhood roadway resurfacing, utility relocation, and swale restoration.

On November 22, 2023, the Procurement Services Division issued Invitation to Bid (ITB) Event No. 208, with an original closing date of December 20, 2023. Addendum No. 3 extended the bid closing date to January 12, 2024. Addendum No. 6 extended the bid closing date again to January 19, 2024.

The City received the following four (4) bids in response to the solicitation, which was opened on January 19, 2024:

- 1. David Mancini & Sons, Inc.
- 2. Lanzo Construction Company
- 3. Man-Con, Incorporated
- 4. Ric-Man International, Inc.

None of these firms claimed a Disadvantaged Business Enterprise status. All four (4) firms were reviewed for compliance with the solicitation requirements. Ric-Man International, Inc., David Mancini and Sons, Inc., and Lanzo Construction Company were deemed non-responsive since they bid over the percentage threshold amounts for line

04/02/2024 CAM #24-0282 items 1, 2, and 5, as required by the solicitation.

As a result of a voluntary price reduction, Man-Con Incorporated reduced its bid by \$600,000. Therefore, Man-Con Incorporated is being recommended for award since the firm met all the solicitation requirements of the ITB, and was deemed the lowest, responsive, and responsible bidder.

# **Resource Impact**

There is a fiscal impact to the City of \$33,841,618.20 for the contract award, which includes allowances of \$2,275,000, and an additional \$999,973 for estimated in-house project management fees, for a total amount of \$34,841,591.20. Funds for this agreement, in the total amount of \$21,189,079 are available in the FY 2024 Community Investment Plan in the accounts listed below, with \$13,652,512.20 contingent upon approval by the City Commission and appropriation of the consolidated budget amendment (CAM #24-0037).
