A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE ALL **NECESSARY** DOCUMENTS TO RECEIVE GRANT FUNDS IN THE AMOUNT OF \$10,000 FROM BROWARD COUNTY THROUGH THE BROWARD COUNTY CULTURAL TOURISM PROGRAM AND AMENDMENTS TO SUCH DOCUMENTS EXTENDING THE GRANT TERM; AND AMENDING THE FINAL OPERATING BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1. 2012 AND ENDING SEPTEMBER 30, 2013, BY ACCEPTING AND APPROPRIATING SUCH GRANT FUNDS AS SET FORTH IN THE ATTACHED EXHIBIT.

WHEREAS, on January 25, 2012, the Parks and Recreation Department submitted a grant application to the Broward County Cultural Tourism Division for Cultural Tourism Grant funds in the amount of \$10,000 in support of the 2013 Memorial Weekend Beach Activities commonly referred to as the Great American Beach Party; and

WHEREAS, the purpose of the Cultural Tourism Grant is to use the arts as a means of promoting tourism in Broward County to enhance its reputation as an attractive destination for tourists; and

WHEREAS, pursuant to Resolution No. 12-175, adopted on September 18, 2012, the City Commission of the City of Fort Lauderdale adopted the Final Operating Budget of the City of Fort Lauderdale, Florida for the Fiscal Year beginning October 1, 2012, and ending September 30, 2013,

WHEREAS, the City received notification of a grant award in the amount of \$10,000 with required matching funds of \$10,0000; and

WHEREAS, Staff recommends that the City Commission accepts the grant;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 2</u>. That the Final Operating Budget of the City of Fort Lauderdale for the Fiscal Year beginning October 1, 2012 and ending September 30, 2013 is hereby amended by accepting and appropriating funds as set forth in the Exhibit, which is attached hereto and incorporated herein.
