

ASSIGNMENT OF CONTRACT FOR SERVICE OF PROCESS AND SUBPOENA SERVICES

Second Assignee accepts the foregoing assignment, and Second Assignee assumes and agrees to perform all of the Assignor's and First Assignee's duties, obligations, and responsibilities under the Contract.
