

RESOLUTION NO. 25-224

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING A CITY OF FORT LAUDERDALE FISCAL YEAR 2026 NOT FOR PROFIT GRANT PARTICIPATION AGREEMENT WITH JAFCO CHILDREN'S ABILITY CENTER, INC., AUTHORIZING EXECUTION OF THE NOT FOR PROFIT GRANT PARTICIPATION AGREEMENT, AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the mission of JAFCO Children's Ability Center, Inc. ("JAFCO"), is "to provide care, safety and support to children and their families within the Jewish community and beyond who are impacted by abuse, neglect, trauma, or developmental disabilities . . . giving every child a place to belong."; and

WHEREAS, JAFCO is committed to serving children from birth to age 22 who have been diagnosed with a developmental disability (including autism, intellectual disability, cerebral palsy, spina bifida, Prader Willi syndrome, and others) or developmental delay; and

WHEREAS, the City's contribution of grant funds to JAFCO will provide case management and respite care for Fort Lauderdale families of children with developmental disabilities, supporting access to medical and educational services; and

WHEREAS, funding JAFCO's provision of services pursuant to this Agreement will serve a legitimate public and municipal purpose;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. The City Commission of the City of Fort Lauderdale, Florida, hereby approves a City of Fort Lauderdale Fiscal Year 2026 Not for Profit Grant Participation Agreement with JAFCO Children's Ability Center, Inc., ("Grant Participation Agreement"), in substantially the form attached to City Commission Agenda Memo #25-1002, and authorizes execution of the Grant Participation Agreement.

SECTION 2. That if any clause, section, or other part of this Resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Resolution shall not be affected thereby, but shall remain in full force and effect.

SECTION 3. That this Resolution shall be in full force and effect upon its adoption.

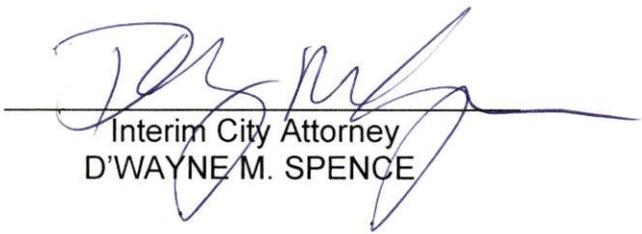
