ORDINANCE NO. C-14-

AN ORDINANCE OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING SUBSECTION 20-74(c) OF THE CODE OF ORDINANCES OF THE CITY OF FORT LAUDERDALE, FLORIDA, AND SCHEDULE I SPECIAL PAY PRACTICES OF THE PAY PLAN OF THE CITY OF FORT LAUDERDALE, FLORIDA, REGARDING ASSIGNMENT PAY, AND PROVIDING FOR SEVERABILITY, REPEAL OF CONFLICTING ORDINANCE PROVISIONS, AND AN EFFECTIVE DATE.

WHEREAS, there are occasions when operational needs of the City's Fire-Rescue Department require that the fire marshal be designated as a deputy fire chief,

NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1.</u> Subsection 20-74(c) of the Code of Ordinances of the City of Fort Lauderdale, Florida, is amended to provide as follows:

A battalion chief, er division chief, or fire marshal may be assigned the duties of deputy fire chief, with the approval of the city manager, and such battalion chief, er division chief, or fire marshal shall be eligible to receive assignment pay and benefits as authorized in the pay plan. Assignment pay and benefits shall be paid only during the period that the employee is actually assigned to perform such duties. An assignment may be transferred to another employee, or terminated at the discretion of the fire chief with the approval of the city manager.

<u>SECTION 2.</u> That Schedule I Special Pay Practices, Assignment Pay, of the Pay Plan of the City of Fort Lauderdale, Florida, is amended to provide as follows:
