ORDINANCE NO. C-14-

AN ORDINANCE OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING SUBSECTION 20-74(c) OF THE CODE OF ORDINANCES OF THE CITY OF FORT LAUDERDALE, FLORIDA, AND SCHEDULE I SPECIAL PAY PRACTICES OF THE PAY PLAN OF THE CITY OF FORT LAUDERDALE, FLORIDA, REGARDING ASSIGNMENT PAY, AND PROVIDING FOR SEVERABILITY, REPEAL OF CONFLICTING ORDINANCE PROVISIONS, AND AN EFFECTIVE DATE.

WHEREAS, there are occasions when operational needs of the City's Fire-Rescue Department require that the fire marshal be designated as a deputy fire chief,

NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. Subsection 20-74(c) of the Code of Ordinances of the City of Fort Lauderdale, Florida, is amended to provide as follows:

A battalion chief, ~~or division chief,~~ or fire marshal may be assigned the duties of deputy fire chief, with the approval of the city manager, and such battalion chief, ~~or division chief,~~ or fire marshal shall be eligible to receive assignment pay and benefits as authorized in the pay plan. Assignment pay and benefits shall be paid only during the period that the employee is actually assigned to perform such duties. An assignment may be transferred to another employee, or terminated at the discretion of the fire chief with the approval of the city manager.

SECTION 2. That Schedule I Special Pay Practices, Assignment Pay, of the Pay Plan of the City of Fort Lauderdale, Florida, is amended to provide as follows:

Battalion Chief	<u>M41</u>	III	If assigned as shift Paramedic Emergency Medical Services (EMS) Supervisor, one additional pay range.
Battalion Chief	<u>M41</u>	III or	If designated Deputy Fire Chief, Salary Range M47
Division Chief	<u>M44</u>	III <u>or</u>	II and Management Category II benefits.
<u>Fire Marshal</u>	<u>M43</u>	<u>III</u>	

CODING: Words, symbols, and letters ~~stricken~~ are deletions; words, symbols, and letters underlined are additions.

Police Major	M44	III	If designated Assistant Police Chief, Salary Range M47 II and Management Category II benefits.
Project Engineer	M31	IV	If assigned to sign and seal engineering drawings and serve as engineer of record, two additional pay ranges.

SECTION 3. That if any clause, section, or other part of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby, but shall remain in full force and effect.

SECTION 4. That all ordinances or parts of ordinances in conflict herewith, be and the same are hereby repealed.

SECTION 5. That this Ordinance shall be in full force and effect immediately upon its final passage.
