TITLE: CONSENT RESOLUTION Authorizing Execution of the Stipulation of

Parties for the Closure of NW 2nd Street Railroad-Highway Grade Crossing, Crossing Number 272554 D, City of Fort Lauderdale, Florida

RECOMMENDATION

It is recommended that the City Commission authorize execution of the Stipulation of Parties **(EXHIBIT 1)** for the Closure of NW 2nd Street Railroad-Highway Grade Crossing, Crossing Number 272554 D, City of Fort Lauderdale, Florida. Execution of this Stipulation alleviates the parties from having a separate administrative hearing pursuant to Chapter 120, Florida Statutes. The City agrees to the closure.

BACKGROUND

As part of the All Aboard Florida rail project with stations planned in Orlando, West Palm Beach, Fort Lauderdale, and Miami, the Florida East Coast, LLC (FEC) needs to permanently close the existing railroad crossing at NW 2nd Street to accommodate the proposed Fort Lauderdale station platform. To do so, FEC must submit an application (EXHIBIT 2) to the Florida Department of Transportation (FDOT) with acceptance from the City of Fort Lauderdale. A Stipulation of the Parties must be executed between the City, FDOT, and FEC agreeing to terms such as responsibilities for documentation, notification, physical changes to the crossing, signage, etc.

Staff will work with FEC officials regarding the maintenance of traffic leading up to the closure. This includes proper notification to property owners and other impacted stakeholders.

There is an existing right-of-way platted easement over the crossing that needs to be vacated. Pursuant to ULDR Sec. 47-24.6, this will go through the Development Review Committee review, Planning and Zoning review and recommendation of approval, and City Commission review and approval at a Public Hearing and adoption of an Ordinance.

Resource Impact
