A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING GRANT AGREEMENT BETWEEN THE CITY OF LAUDERDALE AND YOUNG MEN'S **CHRISTIAN** ASSOCIATION OF SOUTH FLORIDA, INC. ("YMCA"); AUTHORIZING THE CONTRIBUTION OF GRANT FUNDS IN THE AMOUNT OF \$2,000,000.00 TO THE YMCA; ALL SUBJECT TO FURTHER TERMS AND CONDITIONS: REPEALING ANY AND ALL RESOLUTIONS IN CONFLICT HEREWITH: AUTHORIZING EXECUTION OF SAME BY THE PROPER CITY OFFICIALS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City wishes to support the Young Men's Christian Association of South Florida, Inc. ("YMCA") through the execution of a Grant Agreement in the amount of \$2,000,000, funded by \$1,000,000 from District 1 and \$1,000,000 from District 2 park bond land acquisition allocations; and

WHEREAS, the Grant Agreement is consistent with the Parks, Recreation and Beaches Advisory Board recommendation of use of park bond dollars on October 23, 2024; and

WHEREAS, the YMCA is developing a new community facility at Holiday Park that includes a pool complex designed to address critical community needs related to water safety, public health, and recreational access; and

WHEREAS, the YMCA has agreed to provide certain activities as outlined in the Grant Agreement; and

WHEREAS, the City's Commission finds the YMCA pool complex construction and agreed to activities serve a significant public purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA AS FOLLOWS:

<u>SECTION 1</u>. That the Recitals set forth are true and correct and incorporated in this Resolution.

<u>SECTION 2</u>. That the City Commission hereby grants funds in the amount of \$2,000,000.00 and authorizes the execution of the Grant Agreement with the YMCA by the proper City Officials,
