TITLE: Motion Approving an Agreement for Lot Clearing Services - Monroe Lawn

Care Service LLC - \$211,200 (estimated three-year total) - (Commission

Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve an Agreement, in substantially the form attached, for Lot Clearing Services with Monroe Lawn Care Service LLC, for an initial three (3)-year contract amount of \$211,200; and authorize the City Manager to approve two (2) additional one (1)-year renewal options, for an estimated annual amount of \$70,400 for a potential total contract amount of \$352,000, contingent upon appropriation of funds.

Background

Section 18-12 of the Code of Ordinances of the City of Fort Lauderdale ("Code") provides for the control of excessive growth of weeds, grass, or undergrowth, and the removal of rubbish, trash, debris, dead trees, and growth of noxious plants or weeds on developed or undeveloped land. Sections 18-13 and 18-14 of the Code prescribe procedures for the City to remove such growth and debris under certain conditions if the owner of the property fails to act upon notice to comply with the Code. The City may employ licensed contractors to perform this work at the expense of the property owner, and this contract shall govern such work.

On December 7, 2023, the Procurement Services Division issued Invitation to Bid (ITB) Event No. 221 for Lot Clearing Services, which opened on December 15, 2023. Four (4) responses were received.

The bid submitted by Monroe Lawn Care Service LLC met the bid requirements and is deemed the low responsive, responsible bidder.

No bidders indicated their status as a Disadvantaged Business Enterprise.
