TITLE: Motion Approving an Agreement for the Rehabilitation of Pump Stations B-

4 and A-20 - Southern Underground Industries, Inc. - \$8,739,415 -

(Commission Districts 1 and 2)

#### **Recommendation**

Staff recommends the City Commission approve an agreement, in substantially the form attached, for the Rehabilitation of Pump Stations B-4 and A-20, with Southern Underground Industries, Inc., in the amount of \$8,739,415, including allowances and contingencies in the amount of \$225,000 for permit fees, testing, and additional labor and material.

#### **Background**

Pump Station B-4 and Pump Station A-20 were constructed in the 1970's so the existing equipment and structures are aging, undersized, and past their useful life. This project is for the rehabilitation and upgrade of these two (2) triplexes sewage pumping stations arranged in a wet-well/dry-well configuration. These repairs will improve overall system performance and increase system efficiency within the collection system for the City. The rehabilitation will also reduce system maintenance required by City staff and improve the reliability by preventing system failures.

The scope of work includes the removal and replacement of all mechanical, electrical, and ventilation equipment; replacement of pumps, pipes, valves, suction and discharge piping; and protective coating of the wet well. The work also includes relocation of all controls outside of the station, any required structural repairs, and restoration of the affected areas.

On August 16, 2024, the Procurement Services Division issued Invitation to Bid (ITB) Event No. 341. The City received the following two (2) bids in response to the solicitation, which opened on October 8, 2024:

- 1. David Mancini and Sons, Inc.
- 2. Southern Underground Industries, Inc.

Neither of the firms claimed a Disadvantaged Business Enterprise status. These two (2) firms were reviewed for compliance with the requirements of the solicitation. Southern Underground Industries, Inc. met all the solicitation requirements of the ITB and was deemed the low, responsive, and responsible bidder.

### Resource Impact

There is a fiscal impact to the City in the amount of \$8,739,415, which includes \$225,000 for allowances and contingencies, with an additional \$150,000 for in-house project management fees and \$250,000 for construction engineering and inspection services, for a total project cost of \$9,139,415. Funds for this agreement, in the total amount of \$9,139,415, are available in the FY2025 Community Investment Plan in the account listed below.
