The Participant will coordinate, promote, produce, and host the event held on May 3-4, 2025, as described in City Commission Agenda Memorandum No. 24-0913, as amended by City Commission Agenda Memorandum No. 25-0292 and the Beach Business Improvement District (BBID) Grant Application.

Both parties ratify and confirm the terms of the Agreement. All other terms and provisions of the Agreement shall remain in full force and effect, except as specifically amended by this First Amendment.


