ORDINANCE NO. C-13-

AN ORDINANCE OF THE CITY OF FORT LAUDERDALE, FLORIDA, RESCINDING ORDINANCE NO.C-87-98, TO DISSOLVE THE NORTHWEST NEIGHBORHOOD IMPROVEMENT DISTRICT (NWNID).

WHEREAS, pursuant to Ordinance No. C-87-98 adopted on December 1, 1987, the Northwest Neighborhood Improvement District was created as a local government neighborhood improvement district pursuant to Section 59, Chapter 87-243, Laws of Florida, currently section 163.506, Florida Statutes; and

WHEREAS, the Northwest Neighborhood Improvement District includes an area of approximately 1,194 acres bounded on the South by West Broward Boulevard, on the West by the municipal boundary of the City of Fort Lauderdale, on the North by West Sunrise Boulevard and on the East by North Andrews Avenue; and

WHEREAS, Ordinance No. C-87-98 established the authority of the Northwest Neighborhood Improvement District to apply for and receive grants; established powers of the District, including ad valorem taxation, special assessment and generic assessment; and established a Board of Directors and Advisory Board; and

WHEREAS, the District is inactive and all the assets have been transferred to the City.

WHEREAS, the City Commission desires to rescind the ordinance creating the District pursuant to its authority under Section 163.506(4), Florida Statutes (2012);

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That Ordinance No. C-87-98, is hereby rescinded, dissolving the Northwest Neighborhood Improvement District.

<u>SECTION 2</u>. That, pursuant to Section 163.5055(b), Florida Statutes (2012), the City Clerk is hereby directed to send a certified copy of this Ordinance to both the Florida Department of Economic Opportunity and the Florida Department of Legal Affairs to notify them of the dissolution of the district within 30 days after the adoption of this ordinance.
