

RESOLUTION NO. 17-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING RESOLUTION 17-198 TO REMOVE TWO PROPERTIES ON THE 2018 NON-AD VALOREM NUISANCE ASSESSMENT ROLL.

WHEREAS, pursuant to Resolution 17-198, adopted on September 13, 2017, the City Commission of the City of Fort Lauderdale, Florida, adopted the Nuisance Abatement Assessment Roll for Fiscal Year 2018; and

WHEREAS, between the development of the tax roll and the adoption of the tax roll, payment was received by the City for two properties and the liens were released; and

WHEREAS, this Resolution will remove these two properties from the Assessment Roll so that the Broward County tax collector can remove the amounts from the two properties' tax bills;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That Exhibit "A" attached to Resolution 17-198 adopted September 13, 2017, is hereby amended to replace same with Exhibit "A" attached hereto.

SECTION 2. That except as herein amended, Resolution 17-198 adopted September 13, 2017, is hereby ratified and reaffirmed.

SECTION 3. That this Resolution shall take effect immediately upon its adoption.
