TITLE: Motion to Authorize Rental of Vehicles – Enterprise Leasing Company of
Florida, LLC - \$173,783 (two year total \$347,566)

Recommendation

It is recommended that the City Commission approve an agreement piggybacking City of Miami Beach contract 2014-176, in substantially the form attached, between the City of Fort Lauderdale and Enterprise Leasing Company of Florida, LLC (Enterprise) for the rental of 26 vehicles in the estimated annual amount of \$173,783 (two year estimated total \$347,566).

Background

The Special Investigations Unit (SID) requires the use of a variety of vehicles to avoid detection while conducting covert investigations. The current contract with Budget Rent-A-Car includes 26 vehicles and expires on July 31, 2015. Enterprise is willing to accommodate requests for deployment of a variety of vehicles for short to extended periods of time without incurring additional costs. The new contract with Enterprise will allow for better quality of service at a decreased cost.

On April 23, 2014 the City of Miami Beach awarded a contract for the rental of vehicles which are used as undercover Police vehicles. Pursuant to Section 2-181(7) Code of Ordinances of the City of Fort Lauderdale, the City may buy from another governmental entity's contract whereby such contract followed formal bid procedures of sealed written bids, public opening, and legal advertising. Contract 2014-176 complies with Section 2-181(7). This contract was awarded by the City of Miami Beach for a three-year term commencing on May 8, 2014 and ending on May 7, 2017 with two additional one-year renewal terms.

Resource Impact

There will be a fiscal impact to the City in the amount of \$173,783 for the rental of the vehicles. The available balance in the chart below reflects the amount remaining after the removal of the purchase order established for this purchase. The existing purchase order for Budget Rent-A-Car (PP150746-02) has a balance of \$51,922.77 and will be

reallocated to the new vendor if approved.
