A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING THE PUBLIC TRANSPORTATION GRANT AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION TO ACCEPT GRANT FUNDING IN THE AMOUNT OF UP TO \$1.633.600.00. FOR THE DESIGN AND CONSTRUCTION OF THE TAXIWAY BRAVO AND QUEBEC REALIGNMENT PROJECT AT THE FORT LAUDERDALE EXECUTIVE AIRPORT, FINANCIAL PROJECT NUMBER 445972-1-94-01; AUTHORIZING THE CITY MANAGER TO EXECUTE THE GRANT AGREEMENT AND TO ACCEPT GRANT FUNDS THE FLORIDA DEPARTMENT TRANSPORTATION ON BEHALF OF THE CITY; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the project is for the design and construction costs of the Taxiway Bravo and Quebec realignment, at the Fort Lauderdale Executive Airport; and

WHEREAS, the project includes but is not limited to: the demolishing and reconstruction as perpendicular taxiways to Runway 9-27 to conform to current Federal Aviation Administration's design standards, installation of new LED taxiway edge lights and guidance signs, as well as in-ground and elevated Runway Guard Light units at the hold-short lines, and modification of the Airport Lighting Control Monitoring system with the new taxiway configuration; and

WHEREAS, the Florida Department of Transportation ("FDOT") has agreed to fund the project, up to the amount of One Million Six Hundred Thirty-Three Thousand Six Hundred dollars and 00/100 cents (\$1,633,600.00); and

WHEREAS, on December 1, 2022, the Aviation Advisory Board supported staff's recommendation to accept the grant amount from FDOT; and

WHEREAS, the City Commission finds that approving the Public Transportation Grant Agreement and acceptance of the grant funds is in the best interest of the City of Fort Lauderdale.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. The Public Transportation Grant Agreement with the Florida Department of

Transportation, for the design and construction of the Taxiway Bravo and Quebec realignment project, at the Fort Lauderdale Executive Airport, Financial Project Number 445972-1-94-01, is hereby approved and the City Manager is authorized to execute the Agreement on behalf of the City of Fort Lauderdale, Florida.

<u>SECTION 2</u>. The City Manager is hereby authorized to accept grant funds on behalf of the City of Fort Lauderdale, Florida, from the Florida Department of Transportation, in the amount of One Million Six Hundred Thirty-Three Thousand Six Hundred dollars and 00/100 cents (\$1,633,600.00), for the design and construction costs of the Taxiway Bravo and Quebec realignment project, at the Fort Lauderdale Executive Airport.

<u>SECTION 3</u>. The Office of the City Attorney shall review and approve as to form all documents prior to their execution by proper City officials.

<u>SECTION 4</u>. All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5.	This Resolution shall be in full force and effect upon final passage and adoption.
