Recommendation

Staff recommends the City Commission approve a second amendment to the license agreement between Ft. Lauderdale Archers, Inc. ("Licensee") and the City of Fort Lauderdale ("City") for property located at 4590 Peters Road ("Property").

Background

On April 20, 2021, the City Commission approved a two (2) year license agreement with Licensee for a portion of the Property for the sole purpose of the archery clubs' activities. Before executing the agreement staff notified the Licensee of the City's intent to utilize the site for an affordable housing project in the future in collaboration with the Housing Authority of the City of Fort Lauderdale ("HACFL").

On October 5, 2021, the City Commission awarded the Property to HACFL for an affordable housing development project.

On November 2, 2022, the City Commission approved a first amendment to the license agreement providing a two-year extension with Licensee.

City staff recommends that the City Commission approve extending the license term with Licensee for an additional two years, starting from May 2, 2025, until May 1, 2027. The proposed second amendment maintains all other terms and conditions outlined in the original license agreement dated April 20, 2021, including the provision allowing either party to terminate the agreement with a 90-day notice.

Resource Impact

There is no fiscal impact associated with this item (the license fee is \$1.00 per year).

SECOND AMENDMENT TO THE LICENSE AGREEMENT

WITNESSETH:

WHEREAS, the CITY and the CLUB entered into a License Agreement on April 20, 2021, for City-owned property located at 4590 Peters Road, Fort Lauderdale, Florida 33317 (hereinafter the "Property"); and

WHEREAS, the CITY and the CLUB entered into a First Amendment to the License Agreement dated April 20, 2021, on November 2, 2022, extending the term for two (2) years; and

WHEREAS, in accordance with the License Agreement dated April 20, 2021, Section 3, CITY shall have the option to extend the term of the License Agreement; and

WHEREAS, CITY and CLUB are in mutual agreement to extend the term of the License Agreement for two (2) additional years beginning on May 2, 2025 to May 1, 2027; and

NOW, THEREFORE, in consideration of the mutual terms and conditions hereinafter set forth, CITY and CLUB agree as follows:

- 1. The above recitals and representations are true and correct and are incorporated herein.
- 2. The term of the License shall be extended for two (2) years with an effective date of May 2, 2025, and shall end at midnight on May 1, 2027.
- 3. All other terms and conditions of the License Agreement shall remain in full force and effect. Both parties hereby ratify the terms and conditions of the License Agreement, as amended.
- 4. City Manager shall be authorized to execute four (4) additional one (1) year term renewals.

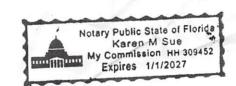
