RESOLUTION NO. 09-222

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA AUTHORIZING THE PROPER CITY OFFICIALS TO AMEND THE FINAL OPERATING BUDGET OF THE CITY OF FORT LAUDERDALE, FLORIDA, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2008, AND ENDING SEPTEMBER 30, 2009, BY APPROPRIATING FUNDS IN THE AMOUNT OF \$258,082.80 AND APPROVING AN AGREEMENT BETWEEN BROWARD COUNTY AND THE CITY FOR COMMUNITY BUS SERVICES.

WHEREAS, public transportation services provided by Broward County need to be supplemented to serve a greater number of people traveling within and throughout the City; and

WHEREAS, public transportation resources are limited and must be used in the most efficient manner to maintain citizen support; and

WHEREAS, both the County and City agree that better public transportation for residents of the City and those persons traveling within or throughout the City is needed; and

WHEREAS, it is desirable to provide an alternative form of public transit service to the residents of the City and those persons traveling within or throughout the City; and

WHEREAS, the City wishes to enter into an Agreement with the County to provide for the funding and provision of Community Bus Services; and

WHEREAS, pursuant to Resolution No. 08-207, adopted on September 16, 2008, the City Commission of the City of Fort Lauderdale adopted the Final Operating Budget of the City of Fort Lauderdale, Florida for the Fiscal Year beginning October 1, 2008 and ending September 30, 2009; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the City Commission of the City of Fort Lauderdale hereby approves an Agreement between Broward County and the City for Community Bus Services and authorizes the proper City officials to execute the Agreement, subject to approval as to form by the City Attorney

SECTION 2. That the Final Operating Budget of the City of Fort Lauderdale for the Fiscal Year beginning October 1, 2008 and ending September 30, 2009 is hereby amended by appropriating

funds in the amount of \$258,082.80 to Fund 129, GSHUTTLE10, Subobject 3299 for Community Bus Services.

<u>SECTION 3</u>. That if any clause, section or other part of this Resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Resolution shall not be affected thereby, but shall remain in full force and effect.

<u>SECTION 4</u>. That all resolutions or parts of resolutions in conflict herewith, be and the same are hereby repealed.

SECTION 5. That this Resolution shall be in full force and effect upon final passage.
