Riverland Woods Boat Launch Ramp was given to the City in 2009 via a grant from Broward County. In 2011 some ramp improvement were completed including a new ramp, new staging docks and repaving of the access road and turning area. The use of this launch ramp has increased since then and the City has been asked by the Lauderdale Isles Civic improvement Association to improve the ramp by widening it and adding floating staging docks.
