TITLE: Motion Approving Increase to the Annual Asphalt, Sidewalk and ADA

Improvements Continuing Contract Cost Capacity – FG Construction, LLC.

- \$1,000,000 (two-year total) - (**Commission Districts 1, 2, 3 and 4**)

Recommendation

Staff recommends the City Commission approve the contract cost capacity to the Annual Asphalt, Sidewalk and ADA Improvements Continuing Contract with FG Construction, LLC by \$1,000,000, increasing the initial term amount from \$1,000,000 to \$2,000,000, annual renewal amounts from \$500,000 to \$1,000,000 for the two (2), one-year renewal options, and potential total contract amount from \$2,000,000 to \$4,000,000.

Background

On February 7, 2023 (CAM# 23-0076), the City Commission awarded the Annual Asphalt, Sidewalk and ADA Improvements Contract (RFQ #12706-623) to FG Construction LLC. This Construction Agreement was awarded for a two (2) year term with two (2) one (1) year options-to-renew, for a potential of four (4) years.

This Agreement is for the City's Annual Asphalt, Sidewalk and ADA access ramps located in Community Development Block Grant qualifying neighborhoods. Work will include, but is not limited to, installation of Type S-3 asphalt, Superpave 9.5 asphalt, thermoplastic pavement marking, milling and leveling of existing asphalt pavement, sidewalk repairs, installation of ADA access ramps, and other items quantified in the agreement.

Due to fiscal year funding constraints at the time of award, the contract was initially awarded for \$1,000,000 with the intention that subsequent cap increases would follow as funding became available and projects were fully defined. It was intended that this Annual Asphalt, Sidewalk, and ADA Ramp Improvements project would have cap increases year-to-year as new neighborhood projects, or portions thereof, were funded for design, permitting, and construction.

Resource Impact

There will be a current fiscal year impact to the City in the estimated amount of \$935,565 for construction. Funds for this agreement in the amount of \$935,565 are available in the

Community Development Block Grant (CDBG) available in the FY2024 Community Investment Plan in the accounts listed below. Future years' expenditures are contingent upon the approval and appropriation of the annual budgets.
