CTMT projects a minimum net profit of 30% of an annual revenue of \$180,000. The yearly operating budget is estimated at \$100,000 which includes a sound and efficient management of costs including operation and maintenance of a fleet of three golf carts, commercial insurance, licensing and permits and fixed and variable operating company expenses.

1. Fixed and Liquid Assets

a. Vehicles:

-2021 Cushman Golf Cart for 8 passengers insured for an actual value of \$15,000

-2024 Gorilla Golf Cart for 6 passengers insured for an actual value of \$17,000

-2024 Club Cart Villager for 8 passengers insured for an actual value of \$20,000

b. Cash in hand and financial backing:

~Liquid cash: \$25,000

-Lines of credit: \$50,000

c. Estimated Revenue:

-We project minimum sales in the order of \$5,000 a month per vehicle

- 2. Operating Costs
 - a. Operating budget for repairs and maintenance of the fleet is estimated at \$12,000 per year.

This includes yearly costs for repairs and maintenance between \$3,000 to \$4,000 per vehicle, including tire replacement, mechanical repairs and additions, balancing, alignments, brakes maintenance, oil changes and gasoline.

b. Budget for commercial insurance is estimated at \$14,500 per year.

The cost of the commercial insurance policy for our fleet of vehicles is fully funded at \$14,500 per year. Each vehicle will carry \$100,000 / \$300,000 public liability and \$100,000 property damage.

c. Budget for fixed and variable operating expenses is estimated at \$12,000 per year.

This budget includes office rent, office supplies, utilities, permits and licenses, bank fees and other variable expenses.

d. Budget for payroll

The payroll for a single driver is estimated at no less than \$24,000 a year. Drivers will be 1099 paid.
