**TITLE:** Public Hearing - Resolution Approving a Waiver of Limitations at 10 Hendricks Isle, for the Installation of Fifteen (15) Wood Mooring Piles Extending a Maximum of +/-35.0' into the Adjacent Rio Grande Waterway – **(Commission District 2)**

**Recommendation**

Staff recommends the City Commission adopt a Resolution approving a Waiver of Limitations for the installation of fifteen (15) wood mooring piles extending a maximum of +/-35.0' into the adjacent Rio Grande Waterway located at 10 Hendricks Isle.

**Background**

The applicant is seeking a resolution granting a Waiver of Limitations (a waiver to allow piles to extend beyond the maximum distance as defined by City Code) of Section 47-19.3 D of the Unified Land Development Regulations (ULDR) for the installation of fifteen (15) wood mooring piles extending a maximum of +/-35.0' from the property line into the adjacent Rio Grande Waterway.

The applicant's Summary Description specifies that the proposed structures are necessary for safely mooring resident's vessels during high winds and severe weather.

Although there is not a fee associated with obtaining a Waiver of Limitations, an application fee in the amount of \$1500.00 is required.

The Marine Advisory Board recommended approval of the application 8:0 (see Exhibit 3) at the September 1, 2022, MAB meeting.

**Resource Impact**

There is a positive fiscal impact in the amount of \$1,500. Revenue related to the application fee is included in the FY2023 Operating Budget in the account listed below.
