TITLE: Broward Regional Safety Action Plan Presentation - **(Commission Districts 1, 2, 3 and 4)**

The Broward Metropolitan Planning Organization (BMPO) and Broward County received a \$5,000,000 grant through the Safe Streets for All (SS4A) Grant program of the United States Department of Transportation to develop countywide implementation strategies to prevent roadway deaths and serious injuries.

As part of the SS4A, the Broward Regional Safety Action Plan (BSAP or Action Plan) is the first step in identifying problems and solutions to make Broward safer for everyone. The mission of the BSAP is to eliminate serious and fatal vehicle crashes within Broward County. The Action Plan will yield three (3) main deliverables: data management, policy recommendations, and a prioritized list of capital improvement projects.

The BSAP was developed collaboratively with stakeholder partners including representatives from the BMPO, Broward County, Florida Department of Transportation, municipalities, hospital representatives, and emergency services representatives.

Once the Action Plan is complete, the prioritized list of projects will be eligible for funding from a variety of sources, including federal discretionary grants and local funding. An action item will follow for endorsement of specific projects by the City Commission prior to a project being eligible for funding. Once a project is programmed there will be additional input throughout the process.

City staff participated in the working groups related to BSAP development and provided input regarding recommended projects within the City of Fort Lauderdale. The three (3) projects within the City are:

- Sistrunk Boulevard – NW 27 Avenue to Andrews Avenue (Local Street)
- Broward Boulevard – Interstate I-95 to NW 1 Avenue (FDOT Arterial)
- NW 31 Avenue – NW 8 Place to McNab Road (County Arterial)

BMPO staff will provide a presentation that includes an overview of the BSAP and the elements that relate to streets within the City of Fort Lauderdale specifically.

The October 23, 2025, City Commission Regular Meeting agenda includes a Resolution to endorse Priority Corridor Projects located within the City of Fort Lauderdale that were identified as part of the Action Plan (CAM #25-0961).
