

RESOLUTION NO. 23-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, ADDING "CHABAD DRIVE" AS THE SECONDARY STREET NAME TO THAT SEGMENT OF NORTHEAST 35TH STREET BETWEEN STATE ROAD A1A AND GALT OCEAN DRIVE, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Chabad-Lubavitch is a movement, a philosophy and a multidimensional organization with a global network of centers, schools, and social services, which focuses on blending different cultures, sharing traditions, promoting Jewish observance, education, and outreach, as well as humanitarian causes and interfaith dialogue; and

WHEREAS, Chabad (חב"ד) is an acronym for three Hebrew words to wit: *chochmah* (wisdom), *binah* (comprehension) and *da'at* (knowledge); and

WHEREAS, the word Lubavitch refers to the name of a city in Russia where the movement was historically based for more than a century; and

WHEREAS, Chabad Lubavitch of Fort Lauderdale ("Chabad") began operating in 1990, renting a small store front on Galt Ocean Drive; and

WHEREAS, Chabad welcomes all people to engage and share in experiencing the richness of the Jewish culture; and

WHEREAS, with a steady growth in programs and attendance, the Chabad expanded its premises and built a permanent community center in the City of Fort Lauderdale, Florida; and

WHEREAS, the Chabad offers community programs and services, to the public, ranging from a Jewish public library, religious services, Hebrew school, adult education, a pre-school, youth programs and family programs; and

WHEREAS, the City Commission of the City of Fort Lauderdale, wishes to designate the segment of Northeast 35<sup>th</sup> Street between State Road A1A and Galt Ocean Drive, as "Chabad Drive" as a secondary street name; and

WHEREAS, Northeast 35<sup>th</sup> Street will be retained as the primary street name;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the segment of Northeast 35<sup>th</sup> Street between State Road A1A and Galt Ocean Drive, shall also be known as "Chabad Drive".

SECTION 2. That the City Clerk is directed to provide a copy of this Resolution to the Broward County Traffic Engineer for future inclusion in the "Official Map of the City of Fort Lauderdale, Florida".

SECTION 3. That the City Clerk is directed to provide a copy of this Resolution to the City Engineer for future inclusion in the "Official Map of the City of Fort Lauderdale, Florida."
