TITLE: Motion Approving Consent of Assignment of Agreement from Lanzo
Trenchless Technologies, Inc.-South to Lanzo Construction Co., Florida -
(Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve consent of assignment of Agreement, in substantially the form attached, for Wastewater Conveyance System Long-term Rehabilitation Program from Lanzo Trenchless Technologies, Inc.-South to Lanzo Construction Co., Florida.

Background

On January 18, 2017, the City awarded Contract No. 466-11799 (two years with three one-year renewals) to Lanzo Trenchless Technologies, Inc.-South for Wastewater Conveyance System Long-term Rehabilitation Program (CAM 17-0054). The Contract was extended administratively for 270 days to October 14, 2022 (Exhibit 4).

On January 1, 2021, The Board of Directors of Lanzo Companies, Inc., approved the transfer of the net assets of both Lanzo Trenchless Technologies Inc North and Lanzo Trenchless Technologies Inc South to Lanzo Construction Co Florida.
