TITLE: Motion Authorizing Settlement of Workers' Compensation Claims in *Arthur Jennings v. City of Fort Lauderdale*, Cases 23-030245DAL and 24-023435DAL – \$150,000 – **(Commission Districts 1, 2, 3 and 4)**

Recommendation

Staff recommends the City Commission approve, as provided for by Sec. 2-151, Code of Ordinances of the City of Fort Lauderdale, Florida, the settlement of the workers' compensation claim in *Arthur Jennings v. City of Fort Lauderdale*, Cases 23-030245DAL and 24-023435DAL, by paying the amount of \$150,000.

Background

Arthur Jennings, a retired Police Officer with the Fort Lauderdale Police Department, filed workers' compensation claims for injuries that occurred on November 29, 2022, and June 28, 2024. The 2022 claim was accepted as compensable under Chapter 440, Florida Statutes, while the 2024 claim was determined to be non-compensable under Chapter 440, Florida Statutes. Mr. Jennings subsequently filed a lawsuit against the City for the 2022 claim on December 1, 2023, and on September 24, 2024, for the 2024 claim.

Pursuant to Sec. 2-151, Code of Ordinances, the claim was reviewed, and a settlement was recommended by the City's Risk Management Committee on June 26, 2025. Staff and defense counsel's evaluation of the potential financial exposure to the City determined that a settlement would provide the most cost-effective outcome. Through negotiations, a settlement was reached in the amount of \$150,000, subject to the approval of the City Commission.

Resource Impact

If approved, there will be a fiscal impact to the City in the amount of \$150,000 which is available in the City's self-insurance fund account listed below.
