TITLE: Second Reading - Ordinance of the City of Fort Lauderdale Florida,
Amending Ordinance Number C-69-76 as Amended to Reduce the
Minimum Number of Meetings Required for the Community Services Board
from Ten (10) to Eight (8) Meetings Per Year - (**Commission Districts 1,
2, 3 and 4**)

Recommendation

Staff recommends the City Commission consider an amendment to Ordinance Number C-69-76, as amended, to reduce the minimum meeting requirements for the Community Services Board (CSB) to eight (8) meetings per year.

Background

The Community Services Board ("CSB"), in its meeting held on August 14, 2023, unanimously voted to send a communication to the City Commission explaining the benefits of reducing the minimum number of meetings. Exhibit 1.

The Board expressed that it has effectively streamlined the workflow process resulting in the board accomplishing the bulk of its work in the Spring and Fall months.

The CSB recognizes that the number of meetings set forth in the ordinance would be a *minimum*. It is anticipated that the board will still meet in excess of that number each year based on the volume of business that comes before the board. The recommended change would allow the CSB more flexibility in scheduling and reduce any unnecessary burden on the volunteer board members, City staff, and most importantly the funded non-profit partner agencies who typically attend every meeting.
