TITLE: Motion Approving Amendment to Agreement to Increase Annual Amount
for Fireworks - 4th of July - Pyrotecnico Fireworks, Inc. – from \$121,100 to
\$171,100 - **(Commission District 2)**

Recommendation

Staff recommends the City Commission approve an amendment to the Agreement, in substantially the form attached, for Fireworks - 4th of July, increasing the annual amount, by an additional \$50,000, from \$121,100 to \$171,100, for the initial one (1)-year fixed and firm contract term and three (3) additional one (1) year renewal periods, for a potential total contract amount from \$484,400 to \$684,400, with Pyrotecnico Fireworks, Inc; and authorize the City manager to execute and approve the renewals, as amended herein.

Background

On May 16, 2023, the City Commission approved the agreement for Fireworks Display - 4th of July with Pyrotecnico Fireworks, Inc., for an initial one (1)-year fixed and firm contract term maximum amount of \$121,100; and authorize the City Manager to approve three (3) additional one (1)-year renewal options in the renewal annual maximum amount of \$121,100, for a potential total contract amount of \$484,400.

After the City Commission approved the agreement, the Procurement Services Division became aware of a bid price discrepancy. At the time, Pyrotecnico submitted its electronic bid, the vendor failed to include pricing for the barge, despite the fact the bid line of the solicitation required for a lump sum amount for the fireworks display combined cost of the fireworks display, barge, and tug. Instead, Pyrotecnico, on or before the bid due date and time, submitted the price for the barge as part of an attachment. Staff advised the City Commission about the bid price discrepancy and need for additional funding at the last Conference Meeting held on June 20th, 2023 (Exhibit 4).

Overall, Pyrotecnico conformed to the Invitation to Bid requirements except for this minor technicality, which the Chief Procurement Officer waived, as permissible, pursuant to section M.11.c.3 of the Procurement Manual.
