(Jentina Littles) for \$50,000.

## **Recommendation**

Staff recommends settlement of this police liability claim in the amount of \$50,000 to Jentina Littles.

## **Background**

The plaintiff, Jentina Littles, was arrested on July 13, 2011 from an incident that took place when a Fort Lauderdale Police Officer approached the plaintiff because of his suspicious behavior. The plaintiff voluntarily provided the officer with his identification, which was then used to run a teletype report. The report indicated that there were no outstanding warrants for the plaintiff and it also indicated that he was not on probation. However, the report also indicated that the plaintiff had a felony history.

The plaintiff voluntarily consented to a search and he was placed in handcuffs for officer safety. The search produced negative results, but the officer continued to detain the plaintiff. Shortly thereafter the officer conducted a second search. A struggle ensued and the officer observed a clear plastic bag containing an unknown substance on the plaintiff which he was able to put in his mouth and swallow before it could be recovered.

The plaintiff was arrested and spent approximately five months in jail before all charges against him were nolle prosequied by the State Attorney's Office on December 12, 2011. The State Attorney's Office determined that while the initial encounter and search was consensual, the officer had no legal right to detain and handcuff the plaintiff. Additionally, the officer did not have probable cause to conduct a second nonconsensual search.

As this claim is in Federal Court, exposure to the City from an adverse verdict is not limited to the Florida statutory cap. Additionally, the plaintiff's attorney would be entitled to fees and costs if a jury were to award a verdict of at least \$1.

The plaintiff has agreed to a settlement in exchange for payment of the \$50,000, subject to the approval of the City Commission.
