

RESOLUTION NO. 16-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING THE PROPER CITY OFFICIALS TO ADOPT A RESOLUTION IN SUPPORT OF THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) TO MANAGE, CONSTRUCT AND DELIVER THE TRAFFIC SIGNAL AND RELATED IMPROVEMENTS AT SW 4<sup>TH</sup> AVENUE AND SW 28<sup>TH</sup> STREET IN ACCORDANCE WITH THE FDOT PROGRAM BULLETIN 15-03 IN COMPLIANCE WITH THE POLICY FOR PROJECTS NOT ON A ROADWAY WITHIN THE STATE HIGHWAY SYSTEM WITHIN THE LOCAL AGENCY'S RIGHT-OF-WAY/LOCAL JURISDICTION AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Local Agency Program is the Florida Department of Transportation's primary delivery mechanism for managing and constructing off-system projects prioritized in its Five-Year Adopted Work Program that for efficiency, innovation, cost and/or time savings may optimize project delivery; and

WHEREAS, the Florida Department of Transportation (FDOT) conducted a study of the Strategic Intermodal System (SIS) within FDOT District 4; and

WHEREAS, the FDOT has identified this project as a SIS priority project on an off-system roadway within the local right-of-way/jurisdiction of the City of Fort Lauderdale not located on the State Highway System; and

WHEREAS, FDOT is authorized by Florida Statutes and Federal funding provisions to undertake projects within the City of Fort Lauderdale geographical limits; and

WHEREAS, those improvements are being managed by the Florida Department of Transportation (FDOT) more particularly described as Financial Project ID 437866-1, which involves the installation of new crosswalks and curb ramps, new signing and pavement markings, new signal equipment with mast arms, and drainage modifications; and

WHEREAS, the CITY is in support of the implementation of the SW 4<sup>th</sup> Avenue and SW 28<sup>th</sup> Street Signal Project to help to improve safety at the intersection; and

WHEREAS, a resolution to endorse FDOT's delivery of said Project within the local agency's right of way/local jurisdiction is required; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City Commission of the City of Fort Lauderdale, Florida hereby supports the Florida Department of Transportation to manage, construct and deliver the installation of a traffic signal and related improvements at the intersection of SW 4<sup>th</sup> Avenue and SW 28<sup>th</sup> Street.

SECTION 2. The Office of the City Attorney shall review and approve as to form all documents prior to their execution by the proper City officials.

SECTION 3. That this Resolution shall be in full force and effect upon final passage
