**TITLE:** Motion to approve the purchase of a 2014 International Workstar truck – Florida Sheriff’s Association contract 13-11-0904 - \$99,730

**Recommendation**

It is recommended that the City Commission approve the purchase of a 2014 International Workstar truck using the Florida Sheriff’s Association contract 13-11-0904 from Navistar, Inc. c/o Rechtein International Trucks, Inc. in the amount of \$99,730, contingent upon City Commission approval of Commission Agenda Memo #14-0175 for a 2014 Aquatech B-15 sewer cleaner body.

**Background**

Unit V5495 is a 2005 Freightliner chassis with a Vactor sewer cleaner body used to clean the gravity sewer collection systems throughout the City of Fort Lauderdale. This vehicle was scheduled to be replaced in December 2011. Unit V5495 has been removed from service due to extensive corrosion. The Aquatech B-15 sewer cleaner body listed on CAM # 14-0175 will be mounted on this 2014 International Workstar chassis.

**Resource Impact**

There will be a fiscal impact to the City in the amount of \$99,730.
