TITLE: Motion Approving Increase in Funds to Contracts for Turf Grass Maintenance, SE, SW, NW Quadrants and Fire Stations – C&M Landscaping, Inc. and VisualScape, Inc. - \$98,646 - **(Commission Districts 1, 2, 3 and 4)**

Recommendation

Staff recommends the City Commission approve an increase in funds to the contracts for turf grass maintenance services for the SE, SW, NW quadrants, and the City’s fire stations with C&M Landscaping, Inc. (“C&M”) and VisualScape, Inc. in the aggregate amount of \$98,646.

Background

The City currently has five contracts and two vendors for turf grass maintenance as detailed on Exhibit 1.

On April 21, 2020, the Commission approved an increase to the contracts, but the requested amount was incorrect (CAM 20-0240). Additional funds are required to correct the previously approved increase and for additional services. Staff is seeking City Commission approval to increase funds for the contracts listed in Exhibit 1 in the aggregate total of \$98,646.
