

RESOLUTION NO. 26-02

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, REAPPOINTING ROSE ANN FLYNN, ESQUIRE AND RICHARD L. DOODY, ESQUIRE, AS CODE ENFORCEMENT SPECIAL MAGISTRATES FOR THE CITY OF FORT LAUDERDALE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Chapter 11 of the Code of Ordinances of the City of Fort Lauderdale, Florida, was adopted to promote, protect and improve the health, safety and welfare of the citizens of Fort Lauderdale by the creation of a code enforcement system; and

WHEREAS, Chapter 11 of the Code of Ordinances of the City of Fort Lauderdale, Florida, establishes the utilization of Special Magistrates for hearing cases involving violations of municipal codes; and

WHEREAS, Chapter 11 of the Code of Ordinances of the City of Fort Lauderdale, Florida, sets forth the criteria requisite for serving as a Special Magistrate; and

WHEREAS, Rose Ann Flynn, Esquire and Richard L. Doody, Esquire meet the qualifications for reappointment as Special Magistrates; and


WHEREAS, the City Commission of the City of Fort Lauderdale deems it to be in the best interest of the citizens of the City of Fort Lauderdale to reappoint Rose Ann Flynn, Esquire and Richard L. Doody, Esquire as Special Magistrates for the City of Fort Lauderdale for purposes of hearing cases involving violations of the Code of Ordinances of the City of Fort Lauderdale, Florida, at a compensation rate of Two Hundred Dollars (\$200.00) per hour for each appearance as the Special Magistrate;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City Commission does hereby reappoint Rose Ann Flynn, Esquire and Richard L. Doody, Esquire as Special Magistrates for the City of Fort Lauderdale for purposes of hearing cases pursuant to the provisions of Chapter 11 of the Code of Ordinances of the City of Fort Lauderdale, Florida, at a compensation rate of Two Hundred Dollars (\$200.00) per hour as the Special Magistrates. An appearance is comprised of pre-hearing preparation; appearing as Special Magistrate and hearing cases on one day; travel time; and executing orders, whether at Community Inspections located at 700 NW 19th Avenue, Fort Lauderdale, Florida 33311, Marine Industries, 221 SW 3rd Avenue, 2nd Floor Meeting Room, Fort Lauderdale, Florida 33312, or elsewhere.

SECTION 2. That Rose Ann Flynn, Esquire and Richard L. Doody, Esquire are hereby reappointed upon passage of this resolution and shall serve until December 31, 2027.


