TITLE: Motion Approving an Amendment to the Installation and Maintenance Bus Shelter Agreement with Broward County Transit to relocate Bus Shelter at Sistrunk Boulevard and NW 12th Avenue

Recommendation

It is recommended that the City Commission approve a motion allowing the City Manager to execute the First Amendment to the Installation and Maintenance Bus Shelter Agreement (Exhibit 1), in substantially the form attached, with Broward County Transit (BCT) to relocate bus shelters on behalf of the City. The bus shelter will be moved from its location on the south side of Sistrunk Boulevard, just west of NW 12th Avenue, to the bus stop located on the south side of Sistrunk Boulevard near the intersection of NW 21st Terrace.

Background

The BCT shelter at bus stop #2411 has been raised as a safety concern by the neighbors in this area. Significant criminal activities including drug dealing and prostitution have been documented by the Police Department at and near this bus shelter.

Staff has coordinated with BCT regarding the relocation of the shelter to a bus stop further west at NW 21st Terrace across from Betty's Soul Food. BCT approved the relocation, which they will implement on behalf of the City in compliance with the terms of the attached Amendment. The estimated cost of relocation of the bus shelter is \$15,185.84, which will be paid by the City. Maintenance of the shelter will remain the responsibility of the City in accordance with the existing agreement between the City and BCT.

Resource Impact

The total project cost is estimated at \$15,185.84 for construction.
