A social worker by trade, Kathleen Cannon understands firsthand the impact non-profits have in the community. Her work impacts individuals, families, and communities in Broward County. With Kathleen at the helm, United Way of Broward County (UWBC), fights for the Health, Education, and Financial Prosperity of EVERY person in our community which has resulted in long-lasting positive change in Fort Lauderdale. As President/CEO of UWBC, Kathleen utilizes her talents, passion, and undeniable ability to recognize unmet needs, then seeks out partners to create positive solutions and financial support. Through 130+ programs that provide essential care, support and stability, she works to heighten the successful convergence of non-

profits, community leaders, volunteers, and local businesses to help those most in need.

With three focus points in mind: HEALTH, EDUCATION, and FINANCIAL PROSPERITY, Kathleen has made it her mission to successfully create and manage key programs, projects, and campaigns that directly impact our community.

Health:

United Way of Broward County's Commission on Behavioral Health & Drug Prevention helps more than 50,000 children and youth live substance-free. With 80 community engagement activities held, more than 12,000 families were reached. This Commission is a broad-based substance misuse prevention and mental health promotion coalition dedicated to reducing negative consequences for individuals, families and communities. It brokers partnerships between federal, state, and local agencies to foster integrated behavioral health efforts, and addresses the issue of substance misuse. They are focused on solutions to close gaps in services and create a better life for all. Their prevention focused efforts also extend to schools with programs like "Rise Above the Stigma" and Broward Youth Coalition (BYC) training. Successful initiatives include but are not limited to:

- Broward Youth Coalition, part of the Commission, is a dynamic group of middle and high school students who act as peer advocates for substance use prevention and mental health promotion in our community.
- "It's OK to Not be OK", a campaign with strategic messaging addressing stress, loneliness, and/or anxiety. It directs individuals to call 988, the suicide hotline or 211 Broward, a 24/7 hotline, for support and/or free resources. The Commission's website, drugfreebroward.org, also provides a prevention resource center with toolkits providing information to support mental and behavioral health issues. There have been 50+ million media impressions resulted from several campaigns raising awareness about the dangers of substance misuse and mental health awareness.

Education:

Kathleen has achieved the goal of helping young people reach their greatest potential through learning and leadership programs. So much so that this FY year alone, 100% of the children without vision increased their functional capabilities. 98% of special needs children decreased their maladaptive behaviors. 81% of special needs children increased their social emotional abilities and 72% of children increased their academic motivation.

Successful initiatives include but are not limited to:

- ReadingPals Program, started 12 years ago, connects volunteers with Pre-K through 2nd-grade students to generate a lifetime love of literacy and to improve reading and comprehension skills to ensure children are reading at grade level. Since inception, more than 2,000 volunteer mentors have dedicated 1 hour/week (for 28 weeks) to read to individual students or a small group. To date, more than 2,450 Broward County Elementary school students have been read to and received a book (not including the 2024/2025 school year). UWBC has distributed more than 96,000 books to elementary school children in Pre-K through 3rd grade. In the 2022-2023 school year, volunteers donated more than 9,600 hours of instruction, and over 5,000 books were given to children in Broward County

Financial Prosperity:

Kathleen Cannon has achieved extraordinary results in empowering individuals to achieve fiscal stability, earn, keep, and grow their assets. Her efforts have profoundly impacted diverse populations, including domestic violence survivors, youth in foster care, veterans, and those facing unemployment or underemployment. Under Kathleen's leadership, 84% of program participants increased or maintained employment, 91% improved their financial well-being, and 98% of foster youth enhanced their life skills. Remarkably, 100% of domestic violence survivors successfully reduced financial barriers, demonstrating

Kathleen's unwavering commitment to fostering lasting financial independence and stability for those she serves. Successful initiatives include but are not limited to:

- For the past 10 years, MISSION UNITED has been a critical program supporting US military service members, Veterans, and their families in Broward County by helping them acclimate to civilian life. Key focus areas include employment services, education, health, legal assistance, financial stability, and housing support. Through MISSION UNITED, UWBC has aligned existing services and created solutions where there are gaps in support. Since inception, MISSION UNITED has provided more than 21,000 Veterans with comprehensive services to help them acclimate to civilian life. One example of how this program works can be seen through the iconic Fort Lauderdale murals that have been unveiled in 2024 through a Key to Service initiative launched in collaboration with The Veterans Trust and BBX Capital. This public art project, created by renowned artist and veteran Dean Davis, celebrates the vital contributions of veterans, first responders, and healthcare professionals. Visitors can scan the QR codes embedded in the murals to access resources, and to learn about donation opportunities and volunteer information.

- o Mural #1, unveiled in July 2024, is currently displayed at the Fort Lauderdale-Hollywood International Airport.

- o Mural #2, unveiled on September 11, 2024, is on display at Fort Lauderdale Fire Station #49

- Project Lifeline Since its inception, Project Lifeline has provided more than 14.5 million pounds of nutritious food to families in need through 33 food banks United for Housing) initiative is a unique, multi-pronged approach to raising both capital and philanthropic funds via collaborative efforts of public and private organizations.

- Kathleen is also an avid supporter of supporting the ALICE population, a driver of innovation, research, and action to improve life across the country for ALICE (Asset Limited, Income Constrained, Employed) families. Using the data from the bi-annual ALICE Reports, a comprehensive, unbiased picture of financial hardship is painted for Broward County. Kathleen has harnessed this data and advocated collaborative equitable solutions that promote financial stability. Her dedication to championing and supporting ALICE individuals and families has resulted in programs specifically benefiting thousands of seniors, veterans, children, and people with disabilities.

Richard Gray, a Fort Lauderdale resident has been a pioneer, trailblazer and innovator not only for Fort Lauderdale but the International LGBTQ+ travel community for the last 33 years. Richard has been a visionary and significant leader, taking a global role in advising destinations and travel industry leaders about the importance of LGBTQ+ tourism. It was Richard's vision of Inclusivity in 1991 when he opened The Royal Palms that he single handedly garnered global media attention and in 1996 he created the first ever destination LGBTQ+ marketing plan for a destination which within 5 years catapulted Fort Lauderdale as the gay capital of Florida. Today Fort Lauderdale is one of the top Ten LGBTQ+ destinations in the USA. On

January 03, 2025 Richard retired as Senior Vice President of Inclusion & Accessibility for Visit Lauderdale, the tourism arm of Broward County.

Richard Gray has made it easier for LGBTQ+ youth to be more accepting of themselves due to his commitment to global inclusion, acceptance and safety. Richard has used his marketing as a way to educate people about LGBTQ+ welcoming. Richard has supported all the community LGBTQ+ non profits and in particular has been a leading voice for the global Transgender community. In 2017 Richard was recognized by the United Nations for his commitment to the Transgender community and Fort Lauderdale was used as a special Case Study by the United Nations World Tourism Organization. Three years ago Richard created an Accessible strategy and marketing campaign highlighting people with invisible and visible disabilities. Fort Lauderdale has now been mapped out for people with disabilities by Wheel the World and Fort Lauderdale is becoming one of the top accessible destinations in the USA thanks to Richard Gray. Most recently Richard oversaw the filming of the first ever blind/vision impaired destination video, most of which was filmed in Fort Lauderdale. No other destination in the USA has created a video to welcome blind/vision impaired visitors, once again showing that Richard is an extraordinary visionary leader.

3. Why is the nominee deserving of this award? (Please do not include website links)

Since 1991 Richard has tirelessly promoted Fort Lauderdale as an LGBTQ+ mecca. His vision and voice has benefited so many local individuals and businesses. In 2024 3.375 million LGBTQ+ visitors came to Greater Fort Lauderdale and spent a massive \$1.35 billion. Most of those visitors stayed in Fort Lauderdale. Since Richard's career started in 1991 he has helped to increase tourism revenue somewhere between \$15 and \$20 billion into the Greater Fort Lauderdale economy with the main recipient being Fort Lauderdale. He has influenced destinations and countries around the world about savvy inclusive marketing and has most definitely been a generator of change. Richard has pushed boundaries and created paths for others to follow. Destination's not only in the USA but the world follow Richard's campaigns, leadership and vision. He is most definitely the man who put Fort Lauderdale on the map with his innovative out of the box marketing strategies and responsible for so many tourists coming to Fort Lauderdale and being so impressed they bought homes here or moved here.

Richard Gray, was the Senior Vice President of Inclusion & Accessibility for Visit Lauderdale, Broward County's Tourism arm. Richard retired on January 03, 2025. Born in London, England, Richard moved to New York in 1982 as an Investment Banker. In 1991 he made Fort Lauderdale his home when he created the acclaimed Royal Palms Resort. In 1995 he developed the Greater Fort Lauderdale's highly successful LGBT+ marketing initiative. An inductee in the International Gay & Lesbian Travel Associations Hall of Fame in 2002, a Fort Lauderdale Home Town Hero and a recipient of the gay + Award for Achievement from MTV/Logo, Richard is passionate about all aspects of travel. A former Vice Chairman and Executive Board Member of the International Gay & Lesbian Travel Association for over 13 years, Richard was responsible for moving their office from Key West to Fort Lauderdale in the late 1990's. This was a clever move as Fort Lauderdale then became their worldwide headquarters and synonymous with gay travel and gave Richard an even bigger platform to spread the message of diversity and inclusion. Richard was named one of the most influential people in the Meetings industry, a Trailblazer, by Successful Meetings in 2016. Q.Digital in December of 2016 gave Richard an honorary award for his commitment to Transgender tourism. In 2017 the United Nations highlighted Richard's Transgender destination leadership and in 2018 he received the 2018 Stonewall Visionary Award. The South Florida Business Journal named Richard as one of the most influential 15 business leaders in South Florida. In 2020 Richard was an OUT100 recipient by OUT magazine as one of the top 100 LGBTQ+ people in the USA. In 2022 Equality Florida honored Richard and Visit Lauderdale with their prestigious Equality Means Business Award. In 2023 Richard received the Travelability Accessibility Superstar Award. In March of 2024 Richard was chosen as recipient of the ITB LGBTQ+ Pioneer

Award 2024 in Berlin, Germany. He was chosen as an individual who really deserved International recognition for his outstanding travel contributions. As a remarkable professional, he played a pivotal role in influencing global standards for serving disadvantaged and marginalized communities. In 2024 Richard received the Travelability Champion Award for his commitment to Accessible tourism. Most recently Richard received the Richard Gray Tourism Legacy Award from the Greater Fort Lauderdale LGBT+ Chamber of Commerce. An annual award that will given out each year to a person who has made a difference in the LGBT+ travel space here in Greater Fort Lauderdale.

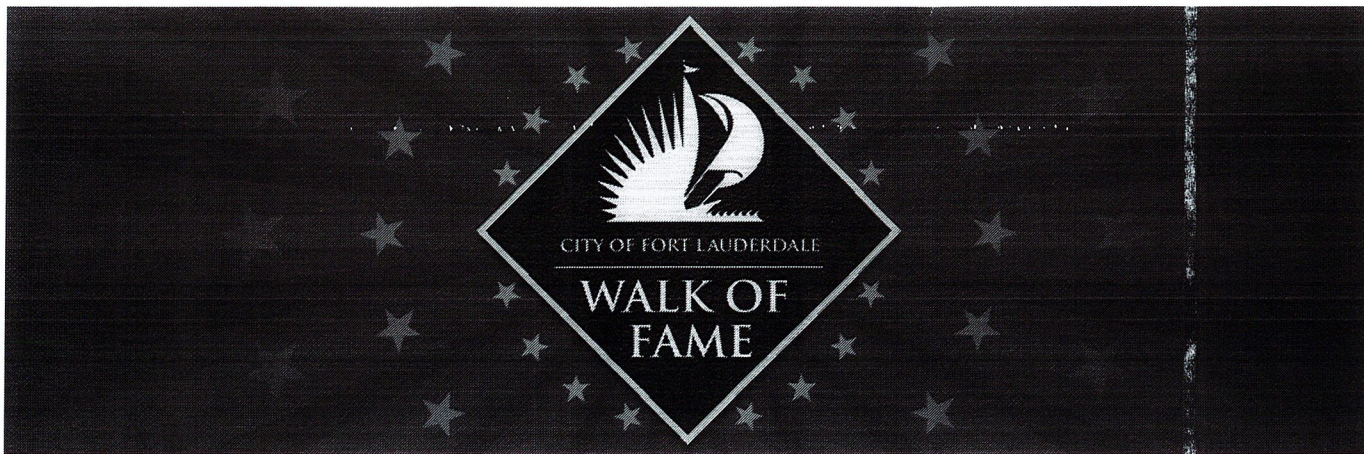

Under his leadership the program has quadrupled and grown to serve the population of our developmentally delayed athletes in Fort Lauderdale and Broward County

He has assisted in raising over 100 million for Special Olympics and other Charities. Mr. Sallarulo founded Sallarulo's Race for Champions 20 years ago. Paul has also coached, chaperoned and transported athletes for several events. He has secured free office space for the Special Olympics for many years and implemented the Special Olympics' Honorary Board program. Paul has also served on our Summer Games committee, Master of Ceremonies for our games, Chairman of the Fund-raising committee and Chairman of Public Relations committee. Paul encourages people to come to Fort Lauderdale to attend our games. Paul also served on the Board of Directors of the Children's Diagnostic Treatment Center in Fort Lauderdale. CDTC is a nationally recognized Center of Excellence for children with special healthcare needs and is the largest non-university related research center in the nation for Pediatric HIV Clinical trials. Mr. Sallarulo's efforts in the community are a remarkable statement of his overall leadership in the community for Special needs children. The CDTC helps thousands of sick, disabled and neglected children in Fort Lauderdale and surrounding areas.

Fostering the spirit of Fort Lauderdale, Paul has provided leadership and personal commitment to the Special Olympics by helping over 500 residents and families of Fort Lauderdale. In 2006, Paul was the only runner in the race, in 2007- 325 people participated, in 2008 over 1,200 people attended and the race is now in its 20th year. He has provided the special Olympics with the means to establish an annual event in Fort Lauderdale that will continue to provide dollars for the future.

Mr. Sallarulo also served on the Board of Directors of the Mental Health Association of Broward County. He was recognized for outstanding advocacy, contributions and achievements that brought increased awareness of disability-related issues. He received the 'Volunteer of the Year' award by the Broward County Advisory Board for Persons with Disabilities and the Broward County Disability Affairs Section, the "2006 Volunteer of the year" by Pinion. Pinion raises funds for the Special Olympics. Mr. Sallarulo served on the Board of "Best Buddies Florida ". Best Buddies International is a 501C (3) nonprofit organization dedicated to enhancing the lives of people with intellectual disabilities by providing opportunities for one-to-one friendships and integrated employment.

Paul always put the needs of the Athletes first. He had spent thousands of hours volunteering for the Special Olympics. He provides an example to the other parents of how our special athletes need to be treated as members of a family and members of society.

Paul is an effective leader and brings out the best in our management team, Athletes and staff. He was instrumental in bringing the Athletes to NSU and having an office there forever, where athletes can go to practice their sport every day. Paul has helped us all to understand that nothing is impossible if we all work together to reach our goals. He is constantly promoting Fort Lauderdale and the Special Olympics and the accomplishment of our Athletes in the business world and the community. We are proud of what Chairman Sallarulo does for our athletes and pleased to nominate him for this recognition. Thank you.

However, awe struck pales in comparison to the person I write about this month. Paul M. Sallarulo, has been a Broward Resident for more than 50 years which in my mind makes him a Pioneer/local. These two foundations for living would ultimately bring to Broward County what I would argue is one of our most impactful individuals. His education consisted of a Bachelor of Business Administration from Baruch College in New York City and after emigrating to Florida he obtained a Master of Business Administration from Nova Southeastern University with Honors. Armed with a degree in higher education and the great deal of financial experience gained on Wall Street prior to moving to Florida, Paul began making an impact on just about every component of our society, consisting of finance, government, health care, education and most important those who are less fortunate. In each of these societal sectors Paul has Given Back to our community on a scale that is mind boggling.

In the world of education at Nova Southeastern University he currently serves on the Board of Trustees, Chair of the Board of Governors of the Wayne Huizenga School of Business, President of the International Alumni Association, Member of the Advisory Board of the Dental College, and he has been the recipient of the Sigma Beta Delta Society-International Honor Society in Business.

Paul has been no slouch in the business world. His company Nexera Medical Inc., where he has served as President and CEO, is the developer and distributor of the world's only re-usable FFP3 Antimicrobial Respirator Mask that protects against all infectious diseases. Prior to involvement in Nexera, Paul had an extensive financial career in capital markets and investment banking while holding senior positions with Wachovia Securities, Prudential, Raymond James, and others. In Florida, he was one of the founders and a Board Member of the Broward Bank of Commerce which ultimately became Stonegate Bank then Centennial Bank today.

Government involvement has always been critical to Paul in that he was able to be a voice as well as an advocate for those less fortunate with physical or mental health disabilities. In fact, it is this area of Giving Back that he has been most impactful in our community. Early on he recognized that in order to make a difference one needs to be in a position to do so. Volunteering his time with key leaders like former Governors Charlie Crist and Jeb Bush Paul assisted with their campaign, transition team and initiatives they were putting forth to better our state's economy and health care systems. Paul was ultimately appointed to the North Broward Hospital District where he served for two four-year terms and ultimately became Chair of the Board of Commissioners. In January of 2006 he was selected by the AHCA (Agency for Health Care Administration of Florida) to serve on the Medical Reform Technical Advisory Panel created by the Florida Legislature to implement medical reform. It was about this time that our community decided it needed to award this person for his Giving Back. His crowning achievements have been with Special Olympics. The annual "Sallarulo Race for Champions" held at NSU has raised over eleven million dollars for these special needs persons. Special Olympics and individuals with disabilities are the culmination of his Giving Back. As a result of this magnanimous effort, Paul and his family have received

the 2016, "Family of the Year Award" for their outstanding leadership and contribution to Special Olympics. Paul is the father of two children, one of which was born with down syndrome. He lives in Lighthouse Point and has been a model parent. In my humble opinion, he is a giant in the world of Giving Back. Interestingly enough when you strip away all the accolades, awards, board positions and public recognition Paul's proudest achievement is to see any one of those Special Olympians cross the finish line at the Sallarulo Race of Champions each year. We are blessed to have this individual within our midst.

Paul M. Sallarulo- Fort Lauderdale Walk of Fame

Mr. Sallarulo is President and CEO of True Defense LLC. He serves on many Corporate Boards including Basinate Industries, Chairman and Board of Directors of Ubii Corporation, Health Bridge Group LLC, Board of Directors-Southwest Charter School Foundation, Inc., Board of Renaissance Charter School, Inc., and Foss Manufacturing Board of Directors. Mr. Sallarulo had an extensive financial career in Capital Markets and investment banking in senior positions with Wachovia Securitias, Prudential, Raymond James, Meridian Capital Markets and CoreStates Capital Markets.

Mr. Sallarulo served as President and CEO of Nexera Medical Inc. until 2015, which is the developer, and distributor of antimicrobial textile products worldwide featuring our Spectra Shield tm Plus, the worlds only Reusable FFP3 Antimicrobial Respirator Mask that can be used in Europe. The Spectra Shield Plus is an antimicrobial mask that protects against infectious and contagious diseases, including the Avian Flu H5N1 Virus (commonly known as the bird flu), Tuberculosis, Streptococcus, staph infections, MRSA, SARS, and more. The Spectra Shield Plus mask is manufactured using Fosshield, a patented technology which embeds a non-toxic copper and silver agent into the fibers of the material. Unlike antimicrobial agents that are applied via topical chemical coatings or include actual metals, the patented, non-leaching, and ion-based antimicrobial technology in Fosshield is blended right into the fabric, polymer, or rubber. As the Company's principal government contact, Mr. Sallarulo was responsible for Nexera receiving the first certification in Europe for an antimicrobial mask, in addition to the first certification of a predicate device "anti bacterial respirator mask" issued by the FDA. His successful negotiations of outsourcing the Company's manufacturing in Asia allowed Nexera to have unlimited manufacturing capabilities for its products. - ❖ An NBHD nurse was one of 6 individuals nationwide to receive an award from the International Sharps Injury Prevention Society.
- ❖ An NBHD epidemiologist was given a Hero of Infection Prevention award. This is a national award given by the Association of Professionals in Infection Control and Epidemiology. She was one of only twelve recipients in the nation and was recognized for her work on reducing ventilator associated pneumonia.
- ❖ A NBHD hospital's (Ventilator Associated Pneumonias) VAP-NET Team won the Team Excellence Award, at the ASQ International Team Competition.
- ❖ A NBHD hospital was the only hospital in South Florida to receive a Medal of Honor Award from the U.S. Department of Health and Human Services, Health

- Resources and Services Administration.** This award was established to honor hospitals that achieve organ donation conversion rates (number of potential donors who actually became donors) of 75% or higher in a 12-month period.
- ❖ The Employment and Training Administration division of the U.S. Department of Labor acknowledged the North Broward Hospital District (NBHD) for its innovative partnerships and programs to address the critical shortage of nurses.
 - ❖ The NBHD was listed as #29 in the Verispan Integrated Healthcare Network Profiling Solution Top 100 which ranked non-specialty integrated healthcare networks on their performance level and degree of integration.
 - ❖ In the NBHD's last year of receiving numerical scoring from JCAHO, NBHD received among the highest-if not the highest-scores in the nation among accredited systems. The combined average scores equaled 99.2. Only two-tenths of one percent of hospitals nation-wide surveyed by the Joint Commission received a score of 100, fewer than two percent of hospitals surveyed received a score of 99 or better and only 7% of hospitals received a score of 98 or better.

It should be noted that there were also numerous state, regional and local awards in addition to the national awards listed immediately above. These awards, mostly based on quality initiatives, have been achieved at a time while the NBHD has had a significant focus on financial improvements.

FINANCE

Under Mr. Sallarulo's leadership, the NBHD enjoyed its most profitable year in its history by posting an increase in net assets of \$75 million for the fiscal year ended June 20, 2006. This comes on the heel of previous record profitability levels for fiscal years 2005 and 2004.

These profitability levels have increased even though the NBHD's tax millage rate has dropped from 2.48 mills to 1.86 mills from 2004 to 2007, a 25% decrease. Mr. Sallarulo has long championed the need to lower the NBHD's millage rate, become less dependent on tax revenues and focus on income from operations. In Mr. Sallarulo's early years on the Board he was often the lone voice for lowering the tax millage, even to the extent where millage rates were adopted by the NBHD with a 6 to 1 vote, Sallarulo opposing. Over the last 3 years, Mr. Sallarulo has been successful in directing the Board to begin lowering the tax millage rates. The rate reduction for fiscal year 2007 to 1.86 mills represents the lowest rate for NBHD since 1985. The NBHD now has an annual cushion of \$72 million between the current millage rate and the millage cap of 2.50 mills. This place the NBHD in position to tap these funds only when needed for future emergencies, while containing costs for the local taxpayers and continuing to provide the highest level of care possible. NBHD has had a focus on key liquidity, capitalization and profitability financial indicators for a number of years with a focus on NBHD

results as compared to Moody's Not For Profit and Moody's A-rated medians. Over the last few years, NBHD has exceeded the Moody's A-rated standards for most of the indicators. The NBHD's financial strategy has been positively received by the bond rating agencies. In a release dated November 8, 2006 Standard and Poor's indicated:

"Standard and Poor's Ratings Services revised its rating outlook on North Broward Hospital District (NBHD), Fla.'s series 2005A, 2005B, 2001, and 1997 revenue bonds, to positive from stable, reflecting a sustained improvement in core operations. Standard and Poor's also affirmed its 'A-' long-term rating and underlying rating (SPUR) on NBHD's bonds. The positive outlook more specifically reflects a sustained improvement in core operations through general cost containment and revenue -enhancement initiatives, including key service line growth, favorable rate increases, better management of productivity, and reduction in length of stay. As a result, NBHD continues to post positive and improving operating surpluses, contributing to an overall improvement in balance sheet strength. NBHD has also improved its cash position and financial profile. The 'A-' rating continues to reflect the four-hospital system's dominant market position in highly competitive Broward County, with a 34% primary market share compared with 31% several years ago; and strong and consistent tax revenue."

The positive results achieved by NBHD under Mr. Sallarulo's leadership have been the result of many years of effort in addressing several key strategic initiatives.

STRATEGY

Commissioner Sallarulo has been the driving force behind numerous reforms at the NBHD aimed at streamlining administrative costs and increasing profitability. As an example, in 2005 the NBHD hired an in-house General Counsel to establish an in-house legal department, ending nearly twenty years of contracting externally for legal services. This strategy has already paid significant dividends in improvements in efficiency, effectiveness and has also provided significant cost savings to the NBHD. Once the in-house legal department is fully developed, the savings is expected to amount to nearly \$3 million per year.

In 2006, as Chairman of the Audit Committee, Commissioner Sallarulo championed the adoption of certain Sarbanes-Oxley Corporate Governance provisions and then initiated the Board's first retreat in decades which focused on Corporate Governance. The retreat, led by the Governance Institute, was highly successful and led to the development of a Governance Committee which is addressing a number of issues geared towards improving the NBHD's governance and transparency, responsiveness and competitive agility in the marketplace.

Under Mr. Sallarulo's chairmanship, the NBHD hired Alan Levine as President/CEO, who was named in Modern Healthcare magazine's August 7, 2006 special supplement as one of 30 leaders who are likely to have a powerful impact on healthcare in the years and decades ahead. Mr. Levine is on the front lines of the

nation's debate regarding Medicaid reform, and is responsible for running the largest public health system in one of two Florida counties that is piloting the market-driven Medicaid reforms.

These steps above all significantly improve the NBHD's strategic position for the future.

In closing, Mr. Sallarulo exhibits exemplary skills and characteristics in the areas of community relations, leadership, finance and strategy.

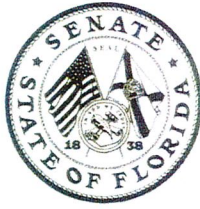



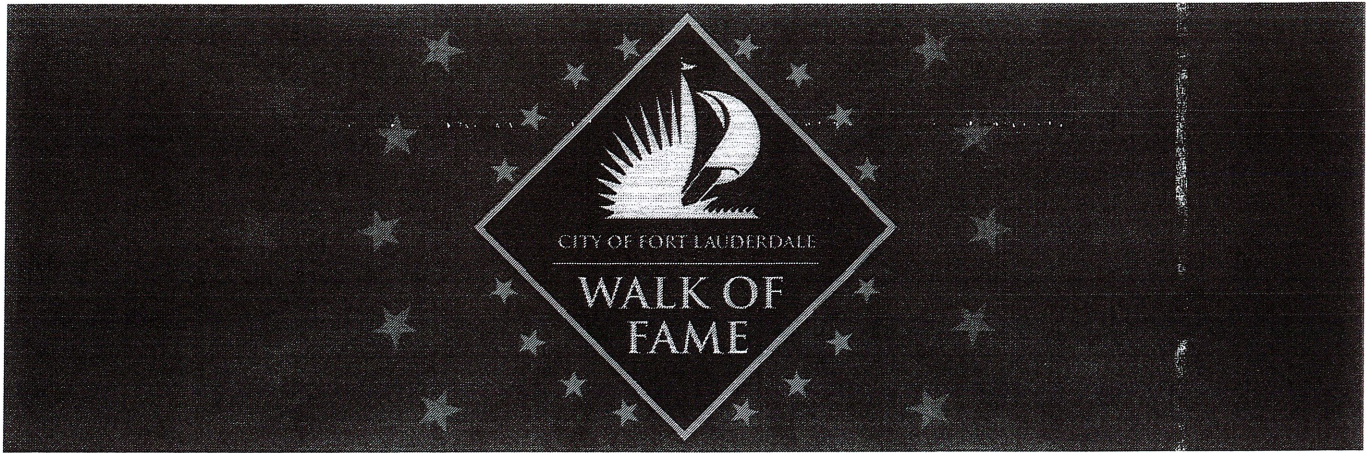
