## **RESOLUTION NO. 13-**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE A SECOND AMENDMENT TO THE AMENDED AND RESTATED LEASE AGREEMENT FOR PARCEL 2 AT FORT LAUDERDALE EXECUTIVE AIRPORT.

WHEREAS, pursuant to Resolution, 11-253 adopted the 7<sup>TH</sup> day of September, 2011, the City entered into an Amended and Restated Lease Agreement ("Lease Agreement") for the lease of Parcel 2 at the Fort Lauderdale Executive Airport with Zeley Aviation, Inc. ("Lessee"); and

WHEREAS, at its meeting of April 17 2012, the City Commission of the City of Fort Lauderdale approved a First Amendment to the Lease Agreement to allow modification of the redevelopment plan resulting in addition of new facilities and reduction in construction costs: and

WHEREAS, Lessee and its sublessees have experienced issues with the redevelopment plan and have presented a revised site plan for City consideration and approval; and

WHEREAS, Lessee has requested and Lessor wishes to execute a Second Amendment to Lease Agreement to reflect: (a) an increase in rent to \$172,275.44 annually effective April 1, 2014; (b) termination of the Lease Agreement on April 1, 2015 if the Lessee fails to construct 20,000 square feet of new hangar facilities, ramp and drainage improvements: and (c) an increase in rent to include five percent (5%) of potential gross rental receipts of the leasehold improvements prior to commencement date of the Second Amendment effective July 31, 2023; and

WHEREAS, Lessee and Lessor also desire to correct an error in the legal description; and

WHEREAS, at its meeting of January 24, 2013, the Aviation Advisory Board recommended approval of such action; and

WHEREAS, the Lessor declares that amending the Lease Agreement is in the best interest of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1.</u> That the proper city officials are authorized to enter into a Second Amendment to the Amended and Restated Lease Agreement between the City and Zeley Aviation, Inc.
