A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE; FLORIDA, APPROVING A FOURTH MUNICIPAL AMENDMENT TO COMCAST ENTERPRISE SERVICES MASTER SERVICES AGREEMENT WITH COMCAST CABLE COMMUNICATIONS MANAGEMENT, LLC TO INCREASE PRICES TO CONTRACTUAL SERVICES AND CONTRACT AMOUNT FOR THE REMAINING TWO ANNUAL CONTRACT RENEWALS; AUTHORIZING THE CITY MANAGER TO EXECUTE THE FOURTH MUNICIPAL AMENDMENT TO COMCAST ENTERPRISE SERVICES MASTER SERVICES AGREEMENT ON BEHALF OF THE CITY; PROVIDING FOR CONFLICTS, PROVIDING FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Information Technology Services Department ("ITS") ensures the City has citywide telecommunication services, including a high-speed communication platform that connects city buildings and integrates with the public network to the internet; and

WHEREAS, the platform provides significant value by enabling seamless communication between city departments and offices, facilitating real-time data sharing, improving response times for essential city services such as emergency response, public safety, and utilities, and supports public Wi-Fi; and

WHEREAS, on May 3, 2022, the City Commission approved the Comcast Enterprise Services Master Services Agreement ("CESMSA") as amended by the First Amendment to MSA No. FI-25848367-DIngb, which allows the City to utilize the Comcast high speed communications platform to create a network between City buildings and a public network to the internet; and

WHEREAS, on February 6, 2024, the City Commission approved a Second Municipal Amendment to the CESMSA to include Business Internet and Ethernet Private Line Services enabling the City the ability to respond to critical situations as well as meeting the City's future needs; and

WHEREAS, on May 7, 2024, the City Commission approved a Third Municipal Amendment to the CESMSA to change Classification from Interstate to Intrastate; and

WHEREAS, City Staff recommends approving a Fourth Municipal Amendment to the CESMSA to provide for the increased pricing information to be effective as of April 8, 2025, and these increases will only be applied to future sales orders for new services; and

WHEREAS, the City Commission finds that approving the Fourth Municipal Amendment to the CESMSA is in the best interest of the City of Fort Lauderdale;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the above recitals are true and correct and incorporated into this Resolution by this reference.

<u>SECTION 2</u>. That the City Commission of the City of Fort Lauderdale, Florida, hereby approves the Fourth Municipal Amendment to Comcast Enterprise Services Master Services Agreement with Comcast Cable Communications Management, LLC, and the City Manager is authorized to execute the Fourth Municipal Amendment to Comcast Enterprise Services Master Services Agreement on behalf of the City of Fort Lauderdale, Florida.

<u>SECTION 3</u>. The Office of the City Attorney shall review and approve as to form all documents prior to their execution by proper City officials.

<u>SECTION 4</u>. That all resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

<u>SECTION 5.</u> If any clause, section, or other part of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered as eliminated and shall in no way affect the validity of the other provisions of this Resolution.

<u>SECTION 6</u>. This Resolution shall be in full force and effect upon final passage and adoption.
